

MINUTE ITEM

5. APPLICATION FOR EASEMENT ACROSS SUBMERGED STATE SOVEREIGN LANDS OF THE SACRAMENTO RIVER REQUIRED FOR BRIDGE RIGHT-OF-WAY SERVING STATE HIGHWAY ROUTE TEH-3-C, RED BLUFF, TEHAMA COUNTY, DIVISION OF HIGHWAYS - W.O. 3740, P.R.C. 2676.9.

After consideration of Calendar Item 20 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE AN EASEMENT AGREEMENT WITH THE STATE DIVISION OF HIGHWAYS, PURSUANT TO SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, FOR A RIGHT-OF-WAY VARYING IN WIDTH FROM 310 TO 330 FEET, WITH A CROSSING LENGTH OF APPROXIMATELY 440 FEET, CONTAINING 3.18 ACRES, MORE OR LESS, IN SECTIONS 17 AND 20, T. 27 N., R. 3 W., M.D.B.& M., AT THE EAST CITY LIMITS OF RED BLUFF, TEHAMA COUNTY, AS DELINEATED ON DIVISION OF HIGHWAYS MAP, DISTRICT II, COUNTY TEH, ROUTE 3, SECTION 3, SHEET NO. 1. THE AREA IS TO PROVIDE FOR THE CONSTRUCTION, MAINTENANCE AND PROTECTION OF A BRIDGE SERVING STATE HIGHWAY ROUTE TEH-3-C. THE CONSIDERATION FOR THE EASEMENT IS THE PUBLIC USE AND BENEFIT.

APPLICATION FOR EASEMENT ACROSS SUBMERGED STATE SOVEREIGN LANDS OF THE SACRAMENTO RIVER REQUIRED FOR BRIDGE RIGHT-OF-WAY SERVING STATE HIGHWAY ROUTE TEH-3-C, RED BLUFF, TEHAMA COUNTY, DIVISION OF HIGHWAYS - W.O. 3740.

An application has been received from the State Division of Highways, pursuant to Section 101.5 of the Streets and Highways Code, for an easement extending across submerged lands of the bed of the Sacramento River varying in width from 310 to 330 feet, with a crossing length of approximately 440 feet, containing 3.18 acres, more or less, at the east city limits of Red Bluff, Tehama County.

The site is required for a bridge crossing for State Highway Route Teh-3-C. No fees or charges are required.
