

MINUTE ITEM

6. APPLICATION FOR PERMIT FOR JETTIES ON TIDE AND SUBMERGED LANDS OF BODEGA BAY, SONOMA COUNTY, U. S. CORPS OF ENGINEERS - W.O. 3779, P.R.C. 2677.9.

After consideration of Calendar Item 3 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE U. S. ARMY CORPS OF ENGINEERS, FOR THE MAINTENANCE AND OPERATION OF TWO JETTIES ACROSS TIDE AND SUBMERGED LANDS SEAWARD OF BODEGA BAY, SONOMA COUNTY, FOR THE PROTECTION OF BODEGA BAY. THE AREA TO BE COVERED BY THE PERMIT IS DESCRIBED AS FOLLOWS:

TRACT 3 (NORTH JETTY)

A PARCEL OF TIDE AND SUBMERGED LAND 80 FEET WIDE AT THE ENTRANCE TO BODEGA HARBOR, SONOMA COUNTY, LYING 40 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK AS DESCRIBED IN PARCEL 2, CHAPTER 218, STATUTES OF 1943, WHICH BEARS N. 74° 40' W., 115 FEET, FROM U.S.E.D. STATION 33 + 97.9 AS DELINEATED ON SHEET NO. 1 OF THAT CERTAIN MAP ENTITLED "SURVEY OF LEGISLATIVE GRANT TO THE COUNTY OF SONOMA, STATUTES 1951, CHAPTER 1406, PAGE 3355," PREPARED BY THE STATE LANDS COMMISSION AND RECORDED IN BOOK 71 OF MAPS, PAGES 4 TO 9, OFFICIAL RECORDS, SONOMA COUNTY; THENCE S. 74° 40' E., 115 FEET, AND S. 89° 23' E., 850 FEET, CONTAINING 1.77 ACRES, MORE OR LESS.

TRACT 4 (SOUTH JETTY)

A PARCEL OF TIDE AND SUBMERGED LAND 80 FEET WIDE AT THE ENTRANCE TO BODEGA HARBOR, SONOMA COUNTY, LYING 40 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK OF 1952, WHICH BEARS N. 64° 08' E., 147 FEET, FROM U.S.E.D. TRIANGULATION STATION "BLUFF", AS DELINEATED ON SHEET NO. 1 OF THAT CERTAIN MAP ENTITLED "SURVEY OF LEGISLATIVE GRANT TO THE COUNTY OF SONOMA, STATUTES 1951, CHAPTER 1406, PAGE 3355," PREPARED BY THE STATE LANDS COMMISSION AND RECORDED IN BOOK 71 OF MAPS, PAGES 4 TO 9, OFFICIAL RECORDS, SONOMA COUNTY; THENCE N. 46° 10' E., 212 FEET, AND S. 89° 23' E., 1,400 FEET, CONTAINING 2.96 ACRES, MORE OR LESS.

THE CONSIDERATION FOR ISSUANCE OF THE PERMIT IS THE BENEFIT TO NAVIGATION.

APPLICATION FOR PERMIT FOR JETTIES ON TIDE AND SUBMERGED LANDS OF BODEGA BAY, SONOMA COUNTY, U. S. CORPS OF ENGINEERS. - W.O. 3779.

Pursuant to Section 6321 of the Public Resources Code, an application has been received for a life-of-structure permit to be issued to the United States of America, Corps of Engineers, for the maintenance and operation of two existing jetties on tide and submerged lands bayward of Bodega Bay, Sonoma County, for protection of the Bay.

The operation of this facility will insure a protected harbor for small craft. No fees or charges are required.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE U. S. ARMY CORPS OF ENGINEERS, FOR THE MAINTENANCE AND OPERATION OF TWO JETTIES ACROSS TIDE AND SUBMERGED LANDS SEAWARD OF BODEGA BAY, SONOMA COUNTY, FOR THE PROTECTION OF BODEGA BAY. THE AREA TO BE COVERED BY THE PERMIT IS DESCRIBED AS FOLLOWS:

TRACT 3 (NORTH JETTY)

A PARCEL OF TIDE AND SUBMERGED LAND 80 FEET WIDE AT THE ENTRANCE TO BODEGA HARBOR, SONOMA COUNTY, LYING 40 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK AS DESCRIBED IN PARCEL 2, CHAPTER 218, STATUTES OF 1943, WHICH BEARS N. 74° 40' W., 115 FEET, FROM U.S.E.D. STATION 33 + 97.9 AS DELINEATED ON SHEET NO. 1 OF THAT CERTAIN MAP ENTITLED "SURVEY OF LEGISLATIVE GRANT TO THE COUNTY OF SONOMA, STATUTES 1951, CHAPTER 1406, PAGE 3355," PREPARED BY THE STATE LANDS COMMISSION AND RECORDED IN BOOK 71 OF MAPS, PAGES 4 TO 9, OFFICIAL RECORDS, SONOMA COUNTY; THENCE S. 74° 12' E., 115 FEET, AND S. 89° 23' E., 850 FEET, CONTAINING 1.77 ACRES, MORE OR LESS.

TRACT 4 (SOUTH JETTY)

A PARCEL OF TIDE AND SUBMERGED LAND 80 FEET WIDE AT THE ENTRANCE TO BODEGA HARBOR, SONOMA COUNTY, LYING 40 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK OF 1952, WHICH BEARS N. 64° 08' E., 147 FEET, FROM U.S.E.D. TRIANGULATION STATION "BLUFF", AS DELINEATED ON SHEET NO. 1 OF THAT CERTAIN MAP ENTITLED "SURVEY OF LEGISLATIVE GRANT TO THE COUNTY OF SONOMA, STATUTES 1951, CHAPTER 1406, PAGE 3355," PREPARED BY THE STATE LANDS COMMISSION AND RECORDED IN BOOK 71 OF MAPS, PAGES 4 TO 9, OFFICIAL RECORDS, SONOMA COUNTY; THENCE N. 46° 10' E., 212 FEET, AND S. 89° 23' E., 1,400 FEET, CONTAINING 2.96 ACRES, MORE OR LESS.
