

MINUTE ITEM

8. \*APPLICATION FOR MINOR STRUCTURE PERMIT, TIDE AND SUBMERGED LANDS, SAN JOAQUIN RIVER NEAR ANTIOCH, CONTRA COSTA COUNTY, CROWN ZELLERBACH CORPORATION - W.O. 3864, P.R.C. 2704.1.

After consideration of Calendar Item 8 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO CROWN ZELLERBACH CORPORATION A 5-YEAR MINOR-STRUCTURE PERMIT AT A TOTAL RENTAL OF \$50, PAYABLE IN ADVANCE, COVERING CERTAIN TIDE AND SUBMERGED LANDS IN THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY, FOR FOUR DAY-BEACON SITES, LOCATED AS FOLLOWS:

APPLICATION FOR MINOR STRUCTURE PERMIT, TIDE AND SUBMERGED LANDS, SAN JOAQUIN RIVER NEAR ANTIOCH, CONTRA COSTA COUNTY, CROWN ZELLERBACH CORPORATION - W.O. 3864.

An application has been received from Crown Zellerbach Corporation for a permit to occupy certain tide and submerged lands in the San Joaquin River, approximately 1.5 miles east of Antioch, Contra Costa County, for the maintenance and use of four day-beacons as channel markers. The day-beacons as installed consist of four black, white-patched piles, in compliance with regulations prescribed in "Aides to Navigation Regulations", published by the U. S. Coast Guard, No. CG-208. A Department of the Army permit for these beacons was issued on March 5, 1956 by the U. S. Corps of Engineers, Sacramento, California, in accordance with the plans shown on the attached exhibits. The applicant's present permit, P.R.C. 1649.1, expired February 5, 1961. The filing fee has been paid.
