APPLICATION FOR APPROVAL OF SUBLEASE UNDER P.R.C. 2364.2, SECTION 36, T. 1 N., R. 1 W., M.D.B.& M., CONTRA COSTA COUNTY, LINDSEY H. SPIGHT -W.O. 3727.

Lease P.R.C. 2364.2, covering Lot 4 and the  $W_2^{\pm}$  of Lot 2, Section 36, T. 1 N., R. 1 W., M.D.B.& M., on Mt. Diable in Contra Costa County, was issued to Lindsey H. Spight for 15 years beginning March 16, 1959, with provision for two renewal periods of 10 years each. The land rental is paid to March 16, 1962.

An application, pursuant to the terms of Lease P.R.C. 2364.2, has been received from Lindsey H. Spight, d.b.a. Diablo Communications Center, for approval of a sublease to Peterson Tractor Company, a corporation, commencing October 1, 1960, for a portion of the leased site (see Exhibits "A", "B" and "C") sufficient for the operation of a mobile repeater transmitting on 952.5 megacycles and receiving on 956.1 megacycles. The sublease is to run for an indefinite period not to exceed the tenure of Lease P.R.C. 2364.2.

The Communications Division of the Department of Finance reported on March 15, 1961, that there is no objection to this sublease.

The statutory filing fee has been paid.
