MINUTE ITEM

13. APPLICATION FOR APPROVAL OF RIGHT-OF-WAY EASEMENT FOR AN OVERHEAD WIRE CROSSING OF THE OLD CHANNEL OF THE FEATHER RIVER, 3-1/2 MILES SOUTH OF YUBA CITY, SUTTER COUNTY, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 3935, P.R.C. 2759.1.

After consideration of Calendar Item 28 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A 49-YEAR EASEMENT AT A TOTAL RENTAL OF \$100 FOR THE CONSTRUCTION, MAINTENANCE AND USE OF AN OVERHEAD WIRE CROSSING OF THE FEATHER RIVER, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

A STRIP OF LAND 10 FEET WIDE IN THE OLD BED OF THE FEATHER RIVER, SUTTER COUNTY, APPROXIMATELY 3.5 MILES SOUTH OF YUBA CITY, THE CENTERLINE BEING DESCRIBED AS FOLLOWS:

BEGINNING AT THE CENTERLINE INTERSECTION OF BARRY ROAD AND GARDEN HIGHWAY IN T. 14 N., R. 3 E., M.D.M.; THENCE S. 1° 00' W., 363.62 FEET AND S. 6° 30' W., 1,056 FEET, MORE OR LESS, TO THE NORTHEASTERLY CORNER OF THE ELIZABETH HAUSS TRACT AS SHOWN ON THAT CERTAIN MAP RECORDED IN MAP BOOK 3 AT PAGE 55 IN THE OFFICE OF THE COUNTY RECORDER OF SUTTER COUNTY; THENCE FROM SAID NORTHEAST CORNER S. 75° 53' E., 293.9 FEET AND S. 81° 36' 45" E., 2,150 FEET, MORE OR LESS, TO THE RIGHT BANK OF THE OLD BED OF THE FEATHER RIVER, BEING THE TRUE POINT OF BEGINNING OF THE HEREIN DESCRIBED CENTERLINE; THENCE FROM SAID TRUE POINT OF BEGINNING S. 81° 36' 45" E., 590 FEET, MORE OR LESS, TO A POINT ON THE LEFT BANK OF THE OLD BED OF THE FEATHER RIVER, CONTAINING 0.09 ACRE, MORE OR LESS.

APPLICATION FOR APPROVAL OF RIGHT-OF-WAY EASEMENT FOR AN OVERHEAD WIRE CROSSING OF THE OLD CHANNEL OF THE FEATHER RIVER, 3-1/2 MILES SOUTH OF YUBA CITY, SUTTER COUNTY, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 3935.

An application has been received from Pacific Gas and Electric Company for approval of a right-of-way easement for a pole line across the old channel of the Feather River 3-1/2 miles south of Yuba City, Sutter County (see Exhibit "A"). The 12,000-volt pole line will cross the Feather River in Section 11, Township 14 North, Range 3 East, M.D.B.& M. (see Exhibit "B").

The statutory filing fee and expense deposit have been paid. No performance bond is required.

The total area being 0.09 acre, the established minimum rental of \$100.00 for 49 years would be applicable.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A 49-YEAR EASEMENT AT A TOTAL RENTAL OF \$100 FOR THE CONSTRUCTION, MAINTENANCE AND USE OF AN OVERHEAD WIRE CROSSING OF THE FEATHER RIVER, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

A STRIP OF LAND 10 FEET WIDE IN THE OLD BED OF THE FEATHER RIVER, SUTTEE COUNTY, APPROXIMATELY 3.5 MILES SOUTH OF YUBA CITY, THE CL RLINE BEING DESCRIBED AS FOLLOWS:

BEGINNING AT THE CENTERLINE INTERSECTION OF BARRY ROAD AND GARDEN HIGHWAY IN T. 14 N., R. 3 E., M.D.M.; THENCE S. 1° OO' W., 363.62 FEET AND S. 6° 30' W., 1,056 FEET, MORE OR LESS, TO THE NORTHEASTERLY CORNER OF THE ELIZABETH HAUSS TRACT AS SHOWN ON THAT CERTAIN MAP RECORDED IN MAP BOOK 3 AT PAGE 55 IN THE OFFICE OF THE COUNTY RECORDER OF SUTTER COUNTY; THENCE FROM SAID NORTHEAST CORNER S. 75° 53' E., 293.9 FEET AND S. 81° 36' 45" E., 2,150 FEET, MORE OR LESS, TO THE RIGHT BANK OF THE OLD BED OF THE FEATHER RIVER, BEING THE TRUE POINT OF BEGINNING OF THE HEREIN DESCRIBED CENTERLINE; THENCE FROM SAID TRUE POINT OF BEGINNING S. 81° 36' 45" E., 390 FEET, MORE OR LESS, TO A POINT ON THE LEFT BANK OF THE OLD BED OF THE FEATHER RIVER, CONTAINING 0.09 ACRE, MORE OR LESS.
