ASSIGNMENT OF MINERAL EXTRACTION LEASES P.R.C.s 210.1, 257.1, 268.1, AND 2038.1, COLUMBIA-SOUTHERN CHE?ICAL CORPORATION, OWENS LAKE, INYO COUNTY - W.O.s 4001, 4002, 4003, AND 4004.

An application has been received from the Pittsburgh Plate Glass Company for the approval of the assignment of Mineral Extraction Leases P.R.C.s 210.1, 257.1, 268.1, and 2038.1 from Columbia-Southern Chemical Corporation, a Delaware corporation, to Pittsburgh Plate Glass Company, a Pennsylvania corporation.

The Columbia-Southern Chemical Corporation, a wholly-owned subsidiary, became a Division of Pittsburgh Plate Glass Company effective January 1, 1961. In the process of changing corporate structure, Pittsburgh Plate Glass Company has acquired all rights and assumed all obligations of Columbia-Southern Chemical Corporation.

Columbia-Southern Chemical Corporation is at the present time the lessee of interests in the following State mineral extraction leases:

- 1. Lease P.R.C. 210.1, issued July 19, 1946, to Pittsburgh Plate Glass Company and assigned to Columbia-Southern Chemical Corporation on September 13, 1951.
- 2. Lease P.R.C. 257.1, issued November 1, 1946, to Pittsburgh Plate Glass Company and assigned to Columbia-Southern Chemical Corporation on September 13, 1951.
- 3. Lease P.R.C. 268.1, issued November 1, 1946, to Pittsburgh Plate Glass Company and assigned to Columbia-Southern Chemical Corporation on September 13, 1951.
- 4. Lease P.R.C. 2038.1, issued February 11, 1958, to Columbia-Southern Chemical Corporation.

Under the terms of Mineral Extraction Leases P.R.C. 210.1, P.R.C. 257.1, and P.R.C. 268.1, liabilities and responsibilities of performance continued with Pittaburgh Plate Glass Company subsequent to the assignments of September 13, 1951.

Paragraph P of Lease P.R.C. 2038.1 states ". . . not to assign this lease, wholly or partially, or transfer or sublet any portion of the State Lands to any person, association of persons, corporation, or any other body without the prior written consent of the State."

The bond requirements have been fulfilled and the \$5 statutory filing fee has been paid on each lease.
