After consideration of Calendar Item 19 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 49-YEAR RIGHT-OF-WAY EASEMENT TO PACIFIC GAS AND ELECTRIC COMPANY, THE TOTAL CONSIDERATION OF \$100 TO BE PAYABLE IN ADVANCE, COVERING PROPERTY DESCRIBED AS FOLLOWS:

THAT CERTAIN STRIP OF TIDE AND SUBMERGED LAND 20 FEET IN WIDTH AND 60 FEET LONG LAING AND BEING 10 FEET ON EITHER SIDE OF A CENTER LINE WHICH BEARS N. 33° 25' 30" E. ACROSS GRIZZLY SLOUGH, SOLANO COUNTY, AS SHOWN ON DRAWING GE-34056, DATED JULY 19, 1946, FILED BY THE PACIFIC PUBLIC SERVICE COMPANY.

APPLICATION FOR APPROVAL OF RIGHT-OF-WAY EASEMENT ACROSS TIDE AND SUBMERGED LANDS OF GRIZZLY SLOUGH, SOLANO COUNTY, PACIFIC GAS AND ELECTRIC COMPANY -W.O. 4044.

An application has been received from Pacific Gas and Electric Company for approval of a right-of-way easement for the operation and maintenance of an existing gas transmission line across tide and submerged lands of Grizzly Slough, Solano County, about 5 miles north of Pittsburg (see Exhibit "A" attached to Calendar Item No. 17). The easement lease replaces Lease P.R.C. 248.1, which expired August 21, 1961.

At the applicant's request, the new easement is to be limited to 20 feet in width, and is to be 60 feet long, containing .027 acre. Since the value of the land at \$500 an acre is \$135, the calculated rental would be less than the established minimum, and therefore the minimum rental of \$100 would apply.

No performance bond is required, as the installation would not adversely affect public use of the site for navigation and fishing, and the salvage value is such as to insure its removal.
