3. APPLICATION FOR EXTENSION OF OCCUPANCY UNDER RIGHT-OF-ENTRY PERMIT IN E $\frac{1}{2}$ OF SECTION 36, T. 24 N., R. 7 E., S.B.B.& M., INYO COUNTY, DIVISION OF HIGHWAYS - W.O. 3329, P.R.C. 2525.9.

After consideration of Calendar Item 10 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO MODIFY RIGHT-OF-WAY ENTRY PERMIT P.R.C. 2525.9, ISSUED TO DIVISION OF HIGHWAYS, COVERING A PORTION OF THE E $\frac{1}{2}$ OF SECTION 36, T. 24 N., R. 7 E., S.B.B.& M., INYO COUNTY, TO EXTEND THE EFFECTIVE DATE OF THE AUTHORIZED OCCUPANCY UNTIL SUCH TIME AS THE SCHOOL LAND INVOLVED IS AGAIN AVAILABLE FOR SALE, OR UNTIL THE COMMISSION HAS FORMULATED A NEW MANAGEMENT POLICY FOR SCHOOL LANDS.

APPLICATION FOR EXTENSION OF OCCUPANCY UNDER RIGHT-OF-ENTRY PERMIT IN E $\frac{1}{2}$ OF SECTION 36, T. 24 N., R. 7 E., S.B.B.& M., INYO COUNTY, DIVISION OF HIGHWAYS - W.O. 3329, P.R.C. 2525.9.

On February 22, 1960, the Commission authorized issuance to the Division of Highways of a right-of-entry permit across school lands in the E $\frac{1}{2}$ of Section 36, T. 24 N., R. 7 E., S.B.B.& M., Inyo County, for the construction and protection of a public highway. The permit was granted on the express understanding that the Division of Highways would, without unnecessary delay, negotiate with the Commission within six months of the date of issuance of the permit as to the date and terms of payment for the lands occupied.

On August 23, 1961, subsequent to declaration by the Commission of a moratorium on the sale of State school lands, the Division of Highways filed an application for purchase of the necessary easement. Because of this moratorium, Highways has now requested an extension of the right of occupancy under the right-of-entry permit until the school land is again available for sale.
