MINUTE ITEM

3. APPLICATION FOR LIFE-OF-STRUCTURE PERMIT FOR THE CONSTRUCTION OF THREE GROINS, AND PERMIT FOR THE DEPOSITION OF FILL MATERIAL ON STATE TIDE AND SUEMERGED LANDS; PIERPONT BAY, VENTURA COUNTY; COUNTY OF VENTURA - W.O. 4200, P.R.C. 2830.9(A)(B).

After consideration of Calendar Item 13 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE COUNTY OF VENTURA FOR THE CONSTRUCTION OF THREE GROINS, AND A PERMIT FOR THE DEPOSITION OF FILL MATERIAL ON PARCELS OF TIDE AND SUBMERGED LANDS DESCRIBED AS FOLLOWS:

APPLICATION FOR LIFE-OF-STRUCTURE PERMIT FOR THE CONSTRUCTION OF THREE GROINS, AND PERMIT FOR THE DEPOSITION OF FIL: MATERIAL ON STATE TIDE AND SUBMERGED LANDS; PIERPONT BAY, VENTURA COUNTY; COUNTY OF VENTURA - W.O. 4200.

An application has been received from the County of Ventura for approval of a life-of-structure permit covering the construction and maintenance of three groins on State-owned tile and submerged lands on Pierpont Bay within the city limits of Ventura. Permission also has been requested to deposit fill material waterward of the mean high tide line. The construction of the groins and the deposition of the fill are part of a beach erosion control program recommended by the U.S. Army Corps of Engineers. The project is to be undertaken jointly by the County of Ventura, the U.S. Army Corps of Engineers, and the Division of Beaches and Parks, with the County maintaining the groins after completion of construction.

The consideration for issuance of the permit is to be the public benefit.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE COUNTY OF VENTURA FOR THE CONSTRUCTION OF THREE GROINS, AND A PERMIT FOR THE DEPOSITION OF FILL MATERIAL ON PARCELS OF TIDE AND SUBMERGED LANDS DESCRIBED AS FOLLOWS:
