## MINUTE ITEM

8. APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR POWER LINE OVER SUBMERGED LANDS, AMERICAN RIVER IN VICINITY OF H STREET BRIDGE, CITY OF SACRAMENTO, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.Q. 4260, P.R.C. 2846.9.

After consideration of Calendar Item 14 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

PURSUANT TO THE PROVISIONS OF PUBLIC UTILITIES CODE SECTION 12808, THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE SACRAMENTO MUNICIPAL UTILITY DISTRICT FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE OF A POWER LINE OVER THE FOLLOWING-DESCRIBED PARCEL OF SUBMERCED LANDS OF THE AMERICAN RIVER, SITUATE IN SACRAMENTO COUNTY:

WITHIN A STRIP OF LAND OF THE UNIFORM WIDTH OF TEN (10) FEET, THE CENTER LINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A NOINT IN THE MEAN LOW WATER LINE ALONG THE RIGHT OR EASTERLY BANK OF THE AMERICAN RIVER, FROM WHICH POINT THE INTER-SECTION OF THE WEST LINE OF THAT CERTAIN RECORD OF SURVEY ENTITLED "PORTION OF SEC. 67, 64, AND SEC. "A" OF SUBDIVISION OF RANCHO DEL PASO", FILED FOR RECORD IN THE OFFICE OF THE RECORDER OF SACRAMENTO COUNTY ON OCTOBER 9, 1961, IN BOOK 18 OF SURVEYS, AT PAGE 15; SAID WEST LINE BEING DESIGNATED "RIGHT BANK AMERICAN RIVER", ON SAID SURVEY; WITH THE SOUTH LINE OF THE "H" STREET BRIDGE, AS SHOWN ON SAID RECORD OF SURVEY, BEARS NORTH 75° 10' EAST 35.0 FEET TO SAID WEST LINE OF SAID SURVEY, AND NORTH 06° 54' 50" EAST ALONG SAID WEST LINE 28.63 FEET TO SAID INTERSECTION; THENCE FROM SAID POINT OF BEGINNING SOUTH 75° 10' WEST 345 FEET MORE OR LESS TO THE MEAN LOW WATER ON THE WESTERLY BANK OF THE AMERICAN RIVER. CONTAINING 0.08 ACRE MORE OR LESS.

## CALENDAR ITEM

APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR POWER LINE OVER SUBMERGED LANDS, AMERICAN RIVER IN VICINITY OF H STREET BRIDGE, CITY OF SACRAMENTO, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. 4260.

The Sacramento Municipal Utility District has applied for a right-of-way easement to construct a power line over the American River. The line will be located about 25 feet southerly from the H Streat Bridge (see Exhibit "A"), and will be used to service street lights which will be installed at the easterly end of the bridge. Public Utilities Code Section 12808 provides as follows:

"A district may construct works across or along any street or public highway, or over any of the lands which are the property of the State, and it shall have the same rights and privileges appertaining thereto as are granted to municipalities within the State. The district shall restore any such street or highway to its former state as near as may be, and in compliance with local ordinances, and shall not use it in a manner to unnecessarily impair its usefulness. A district may also construct its works across any stream or watercourse."

IT IS RECOMMENDED THAT, PURSUANT TO THE PROVISIONS OF PUBLIC UTILITIES CODE SECTION 12808, THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE SACRAMENTO MUNICIPAL UTILITY DISTRICT FOR THE CON-STRUCTICN, OPERATION, AND MAINTENANCE OF A POWER LINE OVER THE FOLLOWING-DESCRIBED PARCEL OF SUEMERGED LANDS OF THE AMERICAN RIVER, SITUATE IN SACRAMENTO COUNTY:

WITHIN A STRIP OF LAND OF THE UNIFORM WIDTH OF TEN (10) FEET, THE CENTER LINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT IN THE MEAN LOW WATER LINE ALONG THE RIGHT OR EASTERLY BANK OF THE AMERICAN RIVER, FROM WHICH POINT THE INTER-SECTION OF THE WEST LINE OF THAT CERTAIN RECORD OF SURVEY ENTITLED "PORTION OF SEC. 67, 64, AND SEC. "A" OF SUBDIVISION OF RANCHO DEL PASO", FILED FOR RECORD IN THE OFFICE OF THE RECORDER OF SACRAMENTO COUNTY ON OCTOBER 9, 1961, IN BOOK )8 OF SURVEYS, AT PAGE 15; SAID WEST LINE BEING DESIGNATED "RIGHT BANK AMERICAN RIVER", ON SAID SURVEY; WITH THE SOUTH LINE OF THE "H" STRENT BRIDGE, AS SHOWN ON SAID RECORD OF SURVEY, BEARS NORTH 75° 10' EAST 35.0 FEET TO SAID WEST LINE OF SAID SURVEY, AND NORTH 06° 54' 50" FAST ALONG SAID WEST LINE 28.63 FEET TO SAID INTERSECTION; THENCE FROM SAID POINT OF BEGINNING SOUTH 75° 10' WEST 545 FEET MORE OR LESS TO THE MEAN LOW WATER ON THE WESTERLY EANK OF THE AMERICAN RIVER. CONTAINING 0.08 ACRE MORE OR LESS.
