18. APPLICATION FOR PERMIT TO CONDUCT SUBMARINE GEOPHYSICAL OPERATIONS; SANTA BARBARA, VENTURA, LOS ANCELES, ORANGE, AND SAN DIEGO COUNTIES; HUMBLE OIL & REFINING COMPANY - W.O. 4273, P.R.C. 2853.1.

After consideration of Calendar Item 13 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO HUMBLE OIL & REFINING COMPANY, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE CONCLISSION, FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OPERATIONS ON THOSE TIDE AND SUB-MERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA:

- A. LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT CONCEPTION, SANTA BARBARA COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND THE SEAWARD EXTENSION (OF A LINE DRAWN DUE SOUTH FROM A POINT ON THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL HAVING ZONE 5 CALIFORNIA COORDINATES OF X = 1,441,189.36 FEET AND Y = 335,615.67 FEET.
- B. LYING BETWEEN THE SEAVARD EXTENSION OF A LINE DRAWN DUE SOUTH FROM A POINT ON THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL HAVING ZONE 5 CALIFORNIA COORDINATES OF X = 1,515,471.78 FEET AND Y = 358,667.70 FEET, AND A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF MEMPORT BEACH AND THE SEAWARD EXTENSION THEREOF.
- C. LYING BETWEEN THE EASTERLY EOUNDARY OF PARCEL A AND THE WESTERLY BOUNDARY OF PARCEL B ABOVE, AND BEING ALSO SEAWARD OF A LINE LOCATED THREE NAUTICAL MILES SEAWARD FROM THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL.
- D. LYING BETWEEN A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAVARD EXTENSION THEREOF, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.
- E. LYING BETWEEN THI: SOUTHEASTERLY BOUNDARY OF PARCEL & AND THE NORTH-WESTERLY BOUNDARY OF PARCEL D ABOVE, AND BEING ALSO SEAWARD OF A LINE LOCATED THREE NAUTICAL MILES SEAWARD FROM THE MEAN HIGH TIDE LINE OF THE GULF OF SANTA CATALINA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM MARCH 15, 1962 TO SEPTEMBER 14, 1962, INCLUSIVE. THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ALL OF ITS INSPECTION COSTS. THE PERMIT IS TO BE EFFECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN IFFECT FOR THE SAME OPERATING AREA.

APPLICATION FOR PERMIT TO CONDUCT SUBMARINE GEOPHYSICAL OPERATIONS; SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; HUMELE OIL & REFINING COMPANY - W.O. 4273.

An application has been received from the Humble Oil & Refining Company for a permit to conduct geophysical operations during the period March 15, 1962, to September 14, 1962, inclusive, on those tide and submerged lands under the jurisdiction of the State Lands Commission lying between a line drawn due West from Point Conception, Santa Barbara County, and the southern boundary of the State of California. The Boards of Supervisors of the counties of Santa Barbara, Ventura, Los Angeles, Grange, and San Diego, and the Mayor and the City Council of the City of Santa Barbara have been informed that this application is to be considered. The statutory filing fee was been paid by the applicant.

Humble Oil & Refining Company has also submitted an application to the Department of Fish and Game for the conduct of seismic operations covering the above-described area.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO HUMBLE OIL & REFINING COMPANY, CONFORMING TO ALL OPERATION CONDITIONS ESTABLISHED BY THE COMMISSION, FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OPERATIONS ON THOSE TIDE AND SUBMERCED LANDS UNDER THE JURISD C-TION OF THE STATE LANDS COMMISSION IN THE AREA:

LYING BETWEEN THE SEAWARD EXTENSION OF A LINE DRAWN DUF SOUTH FROM A POINT ON THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL HAVING ZONE 5 CALIFORNIA COORDINATES OF x = 1,515,471.78 FEET AN Y = 338,667.70 FEET, AND A LINE FORMING THE NORTHWESTERLY BOUNDARD OF THE CITY OF NEWPORT BEACH AND THE SEAWARD EXTENSION THEREOF.
- C. LYING BETWEEN THE EASTERLY BOUNDARY OF PARCEL A AND THE WESTERLY BOUNDARY OF PARCEL B ABOVE, AND BEING ALSO SEAWARD OF A LINE LOCATED THREE NAUTICAL MILES SEAWARD FROM THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL
- D. LYING BETWEEN A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAMARD EXTENSION THEREOF, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

E. LYING BETWEEN THE SOUTHEASTERLY BOUNDARY OF PARCEL B AND THE NORTH-WESTERLY BOUNDARY OF PARCEL D ABOVE, AND BEING ALSO SEAWARD OF A LINE LOCAFED THREE NAUFICAL MILES SEAWARE FROM THE MEAN HIGH TIDE LINE OF THE GULF OF SANTA CATALINA.
