26. APPLICATION FOR RIGHT-OF-WAY LASEMENT FOR A PIPELINE CROSSING OVER FEATHER RIVER, YUBA AND SUTTER COUNTIES; SOUTHERN PACIFIC PIPE LINES, INC. - W.C. 4231, P.R.C. 2855.11

After consideration of Calendar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 49-YEAR RIGHT-OF-WAY EASE-MENT TO SOUTHERN PACIFIC PIPE LINES, INC., AT A TOTAL RENTAL OF \$127.40 PAYABLE IN ADVANCE, FOR THE CONSTRUCTION AND MAINTENANCE OF A PIPE LINE ON THE SOUTHERN PACIFIC RATLROAD BRIDGE, CROSSING THE FEATHER RIVER. THE PROPERTY IS DESCRIBED AS FOLLOWS:

A STRIP OF SUBMERGED LAND 10 FEET WIDE EXTENDING ACROSS THE BED OF THE FEATHER RIVER IN SUITER AND MUBA COUNTIES, LOCATED AFPROXIMATELY 12 MILES NORTHWEST OF MARYSVILLE; THE CENTERLINE OF SAID STRIP BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE LOW WATER MARK ON THE RIGHT BANK OF THE FEATHER RIVER WHICH BEARS S. 0° 21' 30" W., 10 FEET AND S. 89° 38' 30" E., C1 FEET MORE OR LESS FROM R.R.E.S. 123 + 09.5 WHICH IS ON THE WESTERLY END OF SOUTHERN PACIFIC RAILROAD BRIDGE BETWEEN MARYSVILLE AND CHICO; THENCE FROM SAID POINT OF BEGINNING S. 89° 38' 30" E., 238 FEET MORE OR LESS TO THE LOW WATER MARK ON THE LEFT BANK OF THE FEATHER RIVER, CONTAINING O.55 ACRE MORE OR LESS.

APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR A PIPELINE CROSSING OVER FEATHER RIVER, YUBA AND SUTTER COUNTIES; SOUTHERN PACIFIC PIPE LINES, INC. - W.O. 4231.

An application has been received from Southern Pacific Pipe Lines, Inc., for a right-of-way easement over the Feather River on the Southern Pacific Company's railroad bridge in T. 15 N., R. 3 E. (see Exhibits "A" and "B"), approximately one mile northwest of Marysville in the counties of Yuba and Sutter, for the purpose of constructing and maintaining an 8-5/8" O.D. welded steel pipe line for conveying oil and/or gas. The easement is 10' wide and 238' long, containing .055 acre. The estimated value of the land is \$500 per acre. The total rental for a 49-year term is calculated to be \$127.40.

The statutory filing fee and expense deposit have been paid.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A 49-YEAR RIGHT-OF-WAY EASEMENT TO SOUTHERN PACIFIC PIPE LINES, INC., AT A TOTAL RENTAL OF \$1.27.40 PAYABLE IN ADVANCE, FOR THE CONSTRUCTION AND MAINTENANCE OF A PIPE LINE ON THE SOUTHERN PACIFIC RAILROAD BRIDGE, CROSSING THE FEATHER RIVER. THE PROPERTY IS DESCRIBED AS FOLLOWS:

A STRIP OF SUBMERGED LAND 10 FEET WIDE EXTENDING ACROSS THE BEL OF THE FEATHER RIVER IN SUTTER AND YUBA COUNTIES, LOCATED APPROXI-MATELY 12 MILES NORTHWEST OF MARYSVILLE; THE CENTERLINE OF SAID STRIP BEING DESCRIPED AS FOLLOWS:

BEGINNING AT A POINT ON THE LOW WATER MARK ON THE RIGHT BANK OF THE FEATHER RIVER WHICH BEARS S. 0° 21' 30" W., 10 FEET AND S. 89° 38' 30" E., 91 FEET MORE OR LESS FROM R.R.E.S. 123 + 09.5 WHICH IS CN THE WESTERLY END OF SOUTHERN PACIFIC RAILROAD BRIDGE BETWEEN MARYSVILLE AND CHICO; THENCE FROM SAID POINT OF BEGINNING S. 89° 38' 30" E., 238 FEET MORE OR LESS TO THE LOW WATER MARK ON THE LEFT BANK OF THE FEATHER RIVER, CONTAINING 0.55 ACRE MORE OR LESS.
