11. APPLICATION FOR A POLE LINE EASEMENT OVER OLD RIVER NEAR TRACY, SAN JOAQUIN AND CONTRA COSTA COUNTIES, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 4258, P.R.C. 2868.1.

After consideration of Calendar Item 10 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE LXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 49-YEAR RIGHT-OF-WAY EASEMENT TO PACIFIC GAS AND ELECTRIC COMPANY FOR THE CONSTRUCTION, MAINTENANCE AND USE OF AN OVERHEAD POLE LINE OVER SUBMERGED LANDS OF OLD RIVER, AT A TOTAL RENTAL OF \$463.98, PAYABLE UPON EXECUTION OF THE LEASE, FOR AN AREA DESCRIBED AS FOLLOWS:

A STRIP OF LAND 100 FEET WIDE EXTENDING ACROSS THE OLD RIVER IN SAN JOAQUIN AND CONTRA COSTA COUNTLES, LYING 50 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT THE SOUTHWEST CORNER OF SECTION 8, TOWNSHIP 1 SOUTH, RANGE 4 EAST, M.D.B.& M., AND RUNNING THENCE NORTH 18° 41' EAST 1656.14 FEET; THENCE NORTH 32° 23' WEST 100 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK ON THE LEFT BANK, EEING THE TRUE POINT OF BEGINNING; THENCE NORTH 32° 23' WEST 215.0 FEET ACROSS THE PARTIALLY FILLED BED OF THE OLD RIVER TO THE ORDINARY HIGH WATER MARK ALONG THE SOUTHEAST SIDE OF BRA'S ISLAND, CONTAINING 0.5 ACRE MORE OR LESS.

APPLICATION FOR A POLE LINE EASEMENT OVER OLD RIVER NEAR TRACY, SAN JOAQUIN AND CONTRA COSTA COUNTLES, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 4258.

An application has been received from Pacific Gas and Electric Company for approval of a 49-year easement over submerged lands of Old River, San Joaquin and Contra Costa Counties, for the construction, maintenance and use of a 12 KV overhead pole line to Bra's Island. The easement site will cross Old River about 9 miles northwest of Tracy (see Exhibit "A"). A staff appraisal has established the value of the submerged lands at \$200 per acre. The calculated rental for the easement for a 49-year per od would be \$463.98.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A 49-YEAR RIGHT-OF-WAY RASEMENT TO PACIFIC GAS AND ELECTRIC COMPANY FOR THE CONSTRUCTION, MAINTENANCE AND USE OF AN OVERHEAD POLE LINE OVER SUBMERGED LANDS OF OLD RIVER, AT A TOTAL REN_AL OF \$463.98, PAYABLE UPON EXECUTION OF THE LEASE, FOR AN ARMA DESCRIBED AS FOLLOWS:

A STRIP OF LAND LCO FEET WIDE EXTENDING ACROSS THE OLD RIVER IN SAN JOAQUIN AND CONTRA COSTA COUNTIES, LYING 50 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT THE SOUTHWEST CORNER OF SECTION 8, TOWNSHIP 1 SOUTH, RANGE 4 EAST, M.D.B.& M., AND RUNNING THENCE NORTH 18° 41' EAST 1656.14 FRET; THENCE NORTH 32° 23' WEST 100 FEET MORE OR LESS. TO THE ORDINARY HIGH WATER MARK ON THE LEFT BANK, BEING THE TRUE POINT OF BEGINNING; THENCE NORTH 32° 23' WEST 215.0 FRET ACROSS THE PARTIALLY FILLED HED OF THE OLD RIVER TO THE ORDINARY HIGH WATER MARK ALONG THE SOUTHEAST SIDE OF BRA'S ISLAND, COFTAINING 0.5 ACRE MORE CR LESS.
