An application has been received from Mexaco Inc. for a geological survey permit covering portions of the tide and submerged lands under the jurisdiction of the State Lands Commission in San Luis Obispo, Monterey, Santa Cruz, San Mateo, San Francisco, Marin, Sonoma, Mendocino, Humbeldt, and Del Norte Counties, for the six-month period commencing April 1, 1962.

IT IS RECOMMENDED THAT THE COMMISSION ANTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO TEXACO INC. A GEOLOGICAL SURVEY PERMIT, IN CONFORMANCE WITH REGULATIONS ADOPTED BY THE COMMISSION, FOR THE PERIOD APRIL 1, 1962, THROUGH SEPTEMBER 30, 1962, AUTHORIZING THE CONDUCT OF GEOLOGICAL SURVEYS ON THOSE TIDE AND SUBMERGED LANDS UNTER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING RETWEEN A LINE DRAWN DUE WEST FROM POINT SAN LUIS, SAN LUIS OBISPO COUNTY, AND THE NORTHERN POUNDARY OF THE STATE OF CALIFORNIA.
