SERVICE AGREEMENT, CH. 555/61; NOYO HARBOR DISTRICT, MENDOCINO COUNTY - W.O. 4065.

Chapter 555/61 conveys certain tide and submerged lands to the Noyo Harbor District, Mendocino Coulty. The State Lands Commission, pursuant to the provisions of Section 6359 of the Public Resources Code, is required within two years from the effective date of the granting statute to survey, monument, plat and record a plat of the granted lands at the cost of the grantee.

The work is to be performed by the State Lands Division Civil Engineering Staff, on a contract basis. An agreement for this purpose has been drawn by the District, which provides for rendering the surveying services at a cost not to exceed \$7,500, as estimated by the State Lands Division.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO EXECUTE A SERVICE AGREEMENT WITH THE NOYO HARBOR DISTRICT, MENDOCINO COUNTY, CALIFORNIA, ON EEHALF OF THE STATE LANDS COMMISSION AS CONTRACTOR, PROVIDING FOR SURVEY-ING SERVICES TO BE RENDERED THE DISTRICT PURSUANT TO THE PROVISIONS OF CHAPTER 555/61, THE PAYMENT TO THE STATE LANDS COMMISSION FOR SAID SERVICES TO HE THE COMMISSION'S ACTUAL COSTS NOT TO EXCEED \$7,500.
