

MINUTE ITEM

5. APPLICATION FOR AMENDMENT OF LEGAL DESCRIPTION OF LIFE-OF-STRUCTURE PERMIT P.R.C. 2847.9 COVERING TIDE AND SUBMERGED LANDS OF THE AMERICAN RIVER NEAR CARMICHAEL, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. 4496.

After consideration of Calendar Item 17 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO AMEND LIFE-OF-STRUCTURE PERMIT P.R.C. 2847.9, BY THE SUBSTITUTION OF THE FOLLOWING DESCRIPTION IN LIEU OF THE DESCRIPTION CONTAINED THEREIN:

WITHIN A STRIP OF LAND OF THE UNIFORM WIDTH OF TEN (10) FEET,
THE CENTER LINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE MEAN LOW WATER LINE ALONG THE SOUTHEASTERLY BANK OF THE AMERICAN RIVER, FROM WHICH POINT THE NORTHWESTERLY CORNER OF THAT CERTAIN 7.346-ACRE TRACT DESIGNATED "SACRAMENTO COUNTY COLOMA TREATMENT PLANT" AS SAID TRACT IS SHOWN ON THAT CERTAIN RECORD OF SURVEY ENTITLED "PORTION OF SUBDIVISION-GMG TITUS - 164 13/100A" RANCHO RIO DE LOS AMERICANOS RECORDED IN THE OFFICE OF THE RECORDER OF SACRAMENTO COUNTY ON MARCH 23, 1961, IN BOOK 17 OF SURVEYS, MAP NO. 37, BEARS SOUTH 45° 42' 13" EAST ALONG THE SOUTHWEST LINE OF SAID G.M.G. TITUS RECORD OF SURVEY 685.88 FEET DISTANT; THENCE, FROM SAID POINT OF BEGINNING NORTH 45° 40' 13" WEST 365 FEET TO A POINT ON THE MEAN LOW WATER LINE ALONG THE NORTH-WESTERLY BANK OF THE AMERICAN RIVER. CONTAINING 0.083 ACRE MORE OR LESS.

ALL OTHER TERMS AND CONDITIONS OF P.R.C. 2847.9 ARE TO REMAIN UNALTERED, AND IN FULL FORCE AND EFFECT.

APPLICATION FOR AMENDMENT OF LEGAL DESCRIPTION OF LIFE-OF-STRUCTURE PERMIT P.R.C. 2847.9 COVERING TIDE AND SUBMERGED LANDS OF THE AMERICAN RIVER NEAR CARMICHAEL, SACRAMENTO COUNTY, SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. 4496.

An application has been received from the Sacramento Municipal Utility District for amendment of the legal description of power line Life-of-Structure Permit P.R.C. 2847.9, covering 0.08-acre more or less of tide and submerged lands of the American River. The permit was approved by the Commission at its meeting of February 27, 1962.

This application for an amendment is occasioned by the need to relocate the proposed power line to avoid crossing a golf course which is to be built by the County of Sacramento. The permit as amended would relocate the proposed power line several hundred feet westerly of the area provided in Permit P.R.C. 2847.9 (see Exhibit "A").

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO AMEND LIFE-OF-STRUCTURE PERMIT P.R.C. 2847.9, BY THE SUBSTITUTION OF THE FOLLOWING DESCRIPTION IN LIEU OF THE DESCRIPTION CONTAINED THEREIN:

WITHIN A STRIP OF LAND OF THE UNIFORM WIDTH OF TEN (10) FEET, THE CENTER LINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE MEAN LOW WATER LINE ALONG THE SOUTHEASTERLY BANK OF THE AMERICAN RIVER, FROM WHICH POINT THE NORTHWESTERLY CORNER OF THAT CERTAIN 7.346 ACRE TRACT DESIGNATED "SACRAMENTO COUNTY COLOMA TREATMENT PLANT" AS SAID TRACT IS SHOWN ON THAT CERTAIN RECORD OF SURVEY ENTITLED "PORTION OF SUBDIVISION-G.M.G. TITUS - 164 13/100A" RANCHO RIO DE LOS AMERICANOS RECORDED IN THE OFFICE OF THE RECORDER OF SACRAMENTO COUNTY ON MARCH 23, 1961, IN BOOK 17 OF SURVEYS, MAP NO. 37, BEARS SOUTH 45° 42' 13" EAST ALONG THE SOUTHWEST LINE OF SAID G.M.G. TITUS RECORD OF SURVEY 685.88 FEET DISTANT; THENCE, FROM SAID POINT OF BEGINNING NORTH 45° 42' 13" WEST 365 FEET TO A POINT ON THE MEAN LOW WATER LINE ALONG THE NORTHWESTERLY BANK OF THE AMERICAN RIVER. CONTAINING 0.083 ACRE, MORE OR LESS.

ALL OTHER TERMS AND CONDITIONS OF P.R.C. 2847.9 ARE TO REMAIN UNALTERED, AND IN FULL FORCE AND EFFECT.
