SELECTION OF VACANT FEDERAL LAND, LIEU LAND APPLICATION NO. 10740, KERN COUNTY, LOS ANGELES LAND DISTRICT; RAYMOND JOSEPH KRANTZ AND LELAND LEROY WESTPHALL - S.W.O. 5925.

On September 30, 1954, an offer was received from Raymond Joseph Krantz and Leland LeRoy Westphall of Glendale, California, to purchase the  $E_2^1$  of  $SE_4^1$  of Section 32, T. 10 N., R. 12 W., and Lot 1 of Section 28, T. 11 N., R. 12 W., S.B.M. (containing a total of 115.80 acres in Kern County), for \$585. The State's application to select the land was filed with the United States Bureau of Land Management on December 23, 1954.

Section 1903(b) of the Commission's rules and regulations requires applicants to deposit such amounts as may be necessary to cover the costs of processing an application. It further provides for cancellation of the application if such deposits are not made subsequent to written notification. In the instant case the applicants were requested on November 24, 1961, by certified mail, to deposit an additional amount of \$260 to cover expenses. Mr. Krantz requested an extension of time within which to deposit the additional amount, to allow him an opportunity to contact Mr. Westphall who was on an extended tour. Inasmuch as no further correspondence had been received, the applicants were again requested, on May 22, 1962, by certified mail, to deposit the additional expense deposit. As of July 23, 1962, this deposit had not been received. It is therefore concluded that the applicants do not wish to proceed with the application, and that the Commission should order it canceled.

The State's application to select the subjec' land has been accepted by the Bureau of Land Management, and the land was listed (conveyed) to the State on January 11, 1962.
