Pacific Gas and Electric Company has applied for a tower-line easement covering 21.02 acres more or less of tide and submerged lands of Carquinez Strait, Contra Costa County (see Exhibit "A"). This is a replacement for Easement P.R.C. 326.1, which expired May 12, 1962, and is to be used for 220 kilovolt tower lines. The rental for the expired easement was \$109.40 per year.

The replacement easement is to have an initial term of 15 years beginning May 13, 1962, with provisions for three renewal periods of 10 years each. The easement area was appraised by the staff, and the rental is to be \$580.90 per year, with the first and last years' rental payable in advance.
