## MINUTE ITEM

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, SACRAMENTO RIVER, SACRAMENTO COUNTY; JEPARIMENT OF PUBLIC WORKS - W.O. 4705, P.R.C. 3001.9.

After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO THE DEPARTMENT OF PUBLIC WORKS, SACRAMENTO COUNTY, WITHOUT PAYMENT OF ROYALTY (THE CONSIDERA-TION BEING THE PUBLIC BENEFIT ARISING FROM THE IMPROVEMENT OF NAVIGATION), AUTHORIZING THE EXTRACTION OF APPROXIMATELY 1,500 CUBIC YARDS OF MATERIAL FROM THE FOLLOWING-DESCRIBED AREA OF TIDE AND SUBMERGED LANDS:

ALL THAT REAL PROPERTY SITUATE IN THE COUNTY OF SACRAMENTO, STATE OF CALIFORNIA. DESCRIBED AS FOLLOWS:

ALL THE PORTION OF THE BEL OF THE SACRAMENTO RIVER WITHIN SECTION 26, TOWNSHIP 9 NORTH, RANGE 4 EAST, MOUNT DIABLO MERIDIAN, DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT OF JUNCTION OF THE ORDINARY HIGH WATER MARK OF THE LEFT BANK OF THE SACRAMENTO RIVER (SAID HIGH WATTER MARK IS DESCRIBED IN DEED RECORDED IN BOOK 4081, AT PAGE 366, OFFICIAL RECORDS OF SACRAMENTO COUNTY) AND THE CENTERLINE OF FIRST BANNON SLOUGH, SAID JUNCTION POINT BEING LOCATED SOUTH 26° 15' 35" WEST 4,920.57 FEET FROM THE NORTHEAST CORNER OF SAID SECTION: 26; THENCE FROM SAID POINT OF BEGINNING THE FOLLOWING SEVEN COURSES AND DISTANCES:

- SOUTH 28° 42' 00" WEST 38.72 FEET,
- NORTH 45° 57' 00" WEST 53.62 FEET,
- NORTH 45° 57' 00" WEST 50.00 FEET,
- SOUTH 44° 03' 00" WEST 80.00 FEET. SOUTH 45° 57' 00" EAST 239.66 FEET, NORTH 44° 03' 00" EAST 84.15 FEET,
- NORTH 33° 10' 05" WEST 150.00 FEET TO THE POINT OF BEGINNING, CONTAINING 0.505 ACRE MORE OR LESS.

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, SACRAMENTO RIVER, SACRAMENTO COUNTY; DEPARTMENT OF PUBLIC WORKS - 5.0. 4705.

An application has been received from the Department of Public Works, Sacramento County, for a permit to dredge approximately 1,500 cubic yards of material from the bed of the Cacramento river for the purpose of creating a navigable waterway between the Sacramento River and the Discovery Park boat-launching facilities which are to be constructed by the applicant and the Department of Fish and Game in Bannon Slough.

Section 6303 of the Public Resources Code provides in part that:

"The commission may grant the privilege of ... extracting material from ... beds of navigable...rivers...for improvement of navigation...upon such terms and conditions and for such consideration as will be for the best interests of this State".

The Corps of Engineers has issued a Department of the Army permit authorizing the proposed dredging operation. The Division of Beaches and Parks has reported that the project will not interfere with recreational use of lands littoral to the tide and submerged lands involved in this application.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE DEPARTMENT OF PUBLIC WORKS, SACRAMENTO COUNTY, WITHOUT PAYMENT OF ROYALTY (THE CONSIDERATION EFING THE PUBLIC BENEFIT ARISING FROM THE IMPROVE-MENT OF NAVIGATION), AUTHORIZING THE EXTRACTION OF APPROXIMATELY 1,000 CUBIC YARDS OF MATERIAL FROM THE FOLLOWING-DESCRIBED AREA OF TIDE AND SEMERGED LANDS:

ALL THAT REAL PROPERTY SITUATE IN THE COUNTY OF SACRAMENTO, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

- NORTH 45° 57' 00" WEST 50.00 FEET, SOUTH 44° 03' 00" WEST 80.00 FEET, SOUTH 45° 57' 00" EAST 239.66 FEET,
- NORTH 44° 03' 00" EAST 84.15 FEET,
- NORTH 33° 10' 05" WEST 150.00 FEET TO THE POINT OF BEGINNING, CONTAINING 0.505 ACRE MORE OR LESS.
