9. APPLICATION FOR 49-YEAR OUTFALL-LINE EASEMENT, STATE SOVEREIGN LANDS OF THE SACRAMENTO RIVER AT RED BLUFF, TEHAMA COUNTY; DIAMOND NATIONAL CORPORATION - W.O. 3243, P.R.C. 3023.1.

After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO DIAMOND NATIONAL CORPORATION A 49-YEAR OUTFALL-LINE EASEMENT, AT A TOTAL RENTAL OF \$150, COVERING THE FOLLOWING-DESCRIBED LANDS:

A PARCEL OF SUBMERCED LAND 20 FEET IN WIDTH IN THE BED OF THE SACRAMENTO RIVER APPROXIMATELY 2 MILES DOWNSTREAM FROM THE HIGH-WAY BRIDGE AT RED BLUFF IN TEHAMA COUNTY, THE CENTERLINE OF SAID PARCEL BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT, ON THE LOW WATER MARK OF THE RIGHT BANK OF THE SACRAMENTO RIVER, WHICH BEARS N. 32° 03' W. 47.97 FEET; N. 49° 11' W. 35.39 FEET, AND N. 40° 49' E. 30 FEET MORE OR LESS FROM POST "BC 20" LOCATED AT THE ORIGINAL MOUTH OF RED BANK CREEK AS DELINEATED ON THAT CERTAIN MAP ENTITIED "PLAT OF THE RANCHO LA BARRANCA COLORADA, FINALLY CONFIRMED TO WILLIAM B. IDE, FEBRUARY 1858", FILED IN BOOK "A" OF DEEDS AT PAGE 63, IN THE OFFICE OF THE TEHAMA COUNTY RECORDER. THENCE FROM SAID POINT OF BEGINNING N. 40° 49' E. 65 FEET TO A FOINT IN THE SACRAMENTO RIVER; SAID PARCEL CONTAINING 0.03 ACRE MORE OR LESS. THE BASIS OF THE ABOVE BEARINGS IS THE GRANT LINE LA BARRANCA COLORALA BC20-BC21.

APPLICATION FOR 49-YEAR OUTFALL-LINE EASEMENT, STATE SOVEREIGN LANDS OF THE SACRAMENTO RIVER AT RED BLUFF, TEHAMA CCUNTY; DIAMOND NATIONAL CORPORATION - W.O. 3243.

The Diamond National Corporation has applied for a 49-year outfall-line easement covering 0.03 acre more or less of State sovereign lands of the Sacramento River at Red Bluff, Tehama County (see Existint "A"), the land to be used for an outfall line for discharge of treated industrial wastes into the Sacramento River.

The Central Valley Regional Water Pollution Control Board, in conjunction with the Department of Fish and Game, has made extensive tests and has issued a permit to the applicant. Inspection of the discharged material will be on a continuing basis.

The area has been examined by staff appraisers, and it was determined that a total rental of \$150 for the easement would apply.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO DIAMOND NATIONAL CORPORATION A 49-YEAR OUTFALL LINE EASEMENT, AT A TOTAL RENTAL OF \$150, COVERING THE FOLLOWING-DESCRIBED LANDS:

A PARCEL OF SUBMERGED LAND 20 FEET IN WIDTH IN THE BED OF THE SACRAMENTO RIVER APPROXIMATELY 2 MILES DOWNSTREAM FROM THE HIGHWAY BRIDGE AT RED BLUFF IN TEHAMA COUNTY, THE CENTERLINE OF SAID PARCEL BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT, ON THE LOW WATER MARK OF THE RIGHT BANK OF THE SACRAMENTO RIVER, WHICH BEARS N. 32° 03' W. 47.97 FEET; N. 49° 11' W. 35.39 FEET, AND N. 40° 49' E. 30 FEET MORE OR LESS FROM POST "BC 20" LOCATED AT THE ORIGINAL MOUTH OF RED BANK CREEK AS DELINEATED ON THAT CERTAIN MAP ENTITLED "PLAT OF THE RANCHO LA BARRANCA COLORADA, FINALLY CONFIRMED TO WILLIAM B. IDE, FEBRUARY 1858", FILED IN BOOK "A" OF DEEDS AT PAGE 63, IN THE OFFICE OF THE TEHAMA COUNTY RECORDER. THENCE FROM SAID POINT OF BEGINNING N. 40° 49' E. 65 FEET TO A POINT IN THE SACRAMENTO RIVER; SAID PARCEL CONTAINING 0.03 ACRE MORE OR LESS. THE BASIS OF THE ABOVE BEARINGS IS THE GRANT LINE LA BARRANCA COLORADA BC20-BC21.
