12. APPLICATION FOR FROSPECTING PERMIT, SAN BERNARDINO COUNTY; DON C. HIBBERT - W.O. 4778; P.R.C. 3100.2.

After consideration of Calendar Item 3 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

PURSUANT TO SECTION 6891 OF THE PUBLIC RESOURCES CODE, THE COMMISSION AUTHORIZES THE EXECUTIVE OFFICER TO EXECUTE AND ISSUE TO DON C. HIBBERT, A TWO-YEAR PROSPECTING PERMIT FOR ALL MINERALS OTHER THAN OIL AND GAS FOR AN AREA OF STATE-OWNED VACANT SCHOOL LAND WITHIN THE NE_{1}^{1} OF SECTION 16, T. 15 N., R. 10 E., S.B.B.& M., SAN BERNARDINO COUNTY, FURTHER DESCRIBED AS FOLLOWS:

STARTING AT THE E_{4}^{1} CORNER OF SECTION 16 AND RUNNING N. 1,200 FEET; N. 88° 51' W. 1,500 FEET; S. 1,200 FEET; AND S. 88° 51' E. 1,500 FEET TO THE PLACE OF BEGINNING, CONTAINING 41.32 ACRES.

An application has been received from Don C. Hibbert for a permit to prospect for all minerals other than oil and gas on 41.32 acres of vacant State school land within the NE_{E}^{1} of Section 16, T. 15 N., R. 10 E., S.B.B.&M., San Bernardino County (see Exhibit "A" attached).

Field reconnaissance has shown that the area for which the application has been made cannot be classified at this time as being known to contain commercially valuable mineral deposits.

As required under Section 6890 of the Public Resources Code, the application was referred to the office of the Attorney General, which office has advised that the application complies with the applicable laws and the rules and regulations of the State Lands Commission.

The \$5 statutory filing fee has been paid, and the permit fee of \$41.32 has been deposited by the applicant.
