9. APPLICATION FOR APPROVAL OF SUBLEASE UNDER LEASE P.R.C. 2364.2, STATE SCHOOL LANDS IN SECTION 36, T. 1 N., R. 1 W., M.D.B.& M., CONTRA COSTA COUNTY; LINDSEY H. SPIGHT - W.O. 5057.

After consideration of Calendar Item 11 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE A SUBLEASE FROM LINDSEY H. SPIGHT, D.B.A. DIABLO COMMUNICATIONS CENTER, TO HEC TRUCKING CORPORATION, FOR A PERIOD NOT TO EXCEED THE TERM OF LEASE P.R.C. 2364.2. THE SUBLEASE IS TO COVER A PORTION OF THE LANDS DESCRIBED IN LEASE P.R.C. 2364.2, AND IS TO BE USED FOR A MOBILE REPEATER, TRANSMITTER, AND RECEIVER.

APPLICATION FOR APPROVAL OF SUBLEASE UNDER LEASE P.R.C. 2364.2, STATE SCHOOL LANDS IN SECTION 36, T. 1 N., R. 1 W., M.D.B. & M., CONTRA COSTA COUNTY; LINDSEY H. SPIGHT - W.O. 5057.

Lease P.R.C. 2364.2, covering Lot 4 and the  $W\frac{1}{2}$  of Lot 2, Section 36, T. 1 N., R. 1 W., M.D.B. & M., on Mt. Diablo in Contra Costa County, was issued to Lindsey H. Spight, d.b.a. Diablo Communications Center, for 15 years beginning March 16, 1959, at an annual rental of \$1,098, with provision for two renewal periods of 10 years each. The lessee is authorized to sublease, subject to prior approval by the Commission.

An application has been received for approval of a sublease to HEC Trucking Corporation for a portion of the leased site sufficient for the installation, maintenance, and operation of a mobile repeater, transmitting on 953.40 MC and receiving on 957.0 MC. The sublease is to run for an indefinite period not to exceed the term of Lease P.R.C. 2364.2, at a monthly rental of \$100.

The Communications Service of the Department of General Services has reported that there is no objection to the proposed installation.
