

MINUTE ITEM

2. APPLICATION TO AMEND LIFE-OF-STRUCTURE PERMIT P.R.C. 3195.9, SAN JOAQUIN RIVER, NEAR LATHROP, SAN JOAQUIN COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 5533.

After consideration of Calendar Item 17 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE AN AMENDMENT OF P.R.C. 3195.9 TO INCORPORATE THE FOLLOWING NEW LEGAL DESCRIPTION:

A STRIP OF TIDE AND SUBMERGED LAND 30 FEET IN WIDTH IN THE BED OF THE SAN JOAQUIN RIVER, SITUATE NEAR LATHROP, SAN JOAQUIN COUNTY; BEING 15 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

COMMENCING AT THE SOUTHEAST CORNER OF THAT PROPERTY DESCRIBED IN A DEED FROM MACK SUNG TO THE COUNTY OF SAN JOAQUIN AS SAME IS RECORDED IN BOOK 1768 AT PAGE 23, RECORDS OF SAN JOAQUIN COUNTY, AND PROCEEDING THENCE N. $67^{\circ} 00'$ W. 362 FEET TO A POINT ON THE SOUTHEASTERLY PROJECTION OF SAID CENTERLINE; THENCE N. $57^{\circ} 00'$ W. 100 FEET MORE OR LESS . ONG SAID PROJECTED CENTERLINE TO A POINT ON THE MEAN HIGH TIDE LINE OF THE EAST BANK OF THE SAN JOAQUIN RIVER, SAID POINT BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE CONTINUING RIVERWARD ALONG SAID CENTERLINE N. $57^{\circ} 00'$ W. 80 FEET, CONTAINING 0.055 ACRE MORE OR LESS.

THE SIDELINES AT THE SOUTHEASTERLY TERMINUS OF THE ABOVE-DESCRIBED STRIP ARE SHORTENED OR LENGTHENED SO AS TO COINCIDE WITH THE AFOREMENTIONED MEAN HIGH TIDE LINE.

APPLICATION TO AMEND LIFE-OF-STRUCTURE PERMIT P.R.C. 3195.9, SAN JOAQUIN RIVER, NEAR LATHROP, SAN JOAQUIN COUNTY; DEPARTMENT OF FISH AND GAME- W.O. 5533.

Life-of-Structure Permit P.R.C. 3195.9, for the construction of an angling access and launching ramp, was issued to the Department of Fish and Game beginning October 22, 1964, covering a parcel of tide and submerged land 20 feet wide and 80 feet long on the east bank of the San Joaquin River near Lathrop, San Joaquin County.

The permittee wishes to change the location, and to increase the width of the parcel a sufficient distance to provide a catwalk for maintenance and operation of the launching ramp.

It is proposed to amend the permit by the deletion of the present legal description and by the substitution therefor of a legal description that will incorporate both the location change and the additional area needed for the catwalk.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO APPROVE AN AMENDMENT OF P.R.C. 3195.9 TO INCORPORATE THE FOLLOWING NEW LEGAL DESCRIPTION:

A STRIP OF TIDE AND SUBMERGED LAND 30 FEET IN WIDTH IN THE BED OF THE SAN JOAQUIN RIVER, SITUATE NEAR LATHROP, SAN JOAQUIN COUNTY; BEING 15 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

COMMENCING AT THE SOUTHEAST CORNER OF THAT PROPERLY DESCRIBED IN A DEED FROM MACK SUNG TO THE COUNTY OF SAN JOAQUIN AS SAME IS RECORDED IN BOOK 1768 AT PAGE 23, RECORDS OF SAN JOAQUIN COUNTY, AND PROCEEDING THENCE N. $67^{\circ} 00'$ W. 362 FEET TO A POINT ON THE SOUTHEASTERLY PROJECTION OF SAID CENTERLINE; THENCE N. $57^{\circ} 00'$ W. 100 FEET MORE OR LESS ALONG SAID PROJECTED CENTERLINE TO A POINT ON THE MEAN HIGH TIDE LINE OF THE EAST BANK OF THE SAN JOAQUIN RIVER, SAID POINT BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE CONTINUING RIVERWARD ALONG SAID CENTERLINE N. $57^{\circ} 00'$ W. 80 FEET, CONTAINING 0.055 ACRE MORE OR LESS.

THE SIDELINES AT THE SOUTHEASTERLY TERMINUS OF THE ABOVE-DESCRIBED STRIP ARE SHORTENED OR LENGTHENED SO AS TO COINCIDE WITH THE AFOREMENTIONED MEAN HIGH TIDE LINE.
