APPLICATION FOR PERMIT TO CONSTRUCT A ROCK BREAKMATER IN SUBMERGED LANDS OF EAGLE LAKE, LASSEN COUNTY; COUNTY OF LASSEN - W.O. 5605.

The County of Lassen has emplied for a permit to construct a breakwater of native rouch off the east-central shoreline of Eagle Lake, located about 10 miles northeast of Susanville.

The breakwater will enclose an area approximately 500 feet by 600 fect, extending over State sovereign land from upland cuned by Lessen County as shown on Exhibit "A". The breakwater is to protect , recreational area designated as a summer camp for youth organizations.
