

17. APPLICATION FOR A PERMIT TO CONDUCT SUBMARINE GEOPHYSICAL OPERATIONS; SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; PAN PETROLEUM COMPANY, INC. - W.O. 5710, P.R.C. 3327.1.

After consideration of Calendar Item 31 attached, and upon motion duly made and unanimsly carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PAN PETROLEUM COMPANY, INC., A GEOPHYSICAL EXPLORATION PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT CONCEPTION, SANTA BARBARA COUNTY, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA, EXCEPT THE FOLLOWING:

1. LANDS INCLUDED IN SECTION 6871.2(b) OF THE PUBLIC RESOURCES CODE;
2. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTH-WESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM SEPTEMBER 1, 1965, THROUGH FEBRUARY 28, 1966.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ALL OF ITS INSPECTION COSTS. THE PERMIT IS TO BE EFFECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN EFFECT FOR THE SAME OPERATING AREA.

APPLICATION FOR A PERMIT TO CONDUCT SUBMARINE GEOPHYSICAL OPERATIONS; SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; PAN PETROLEUM COMPANY, INC. - W.O. 5710.

An application has been received from Pan Petroleum Company, Inc., for a permit to conduct geophysical operations during the six-month period commencing September 1, 1965, in the area from Point Conception south to the southern border of the State of California.

The Boards of Supervisors of the Counties of Santa Barbara, Ventura, Los Angeles, Orange, and San Diego, and the Mayor and the City Council of the City of Santa Barbara have been informed that this application is to be considered. The statutory filing fee has been paid by the applicant. Pan Petroleum Company, Inc., also has submitted an application to the Department of Fish and Game for the conduct of seismic operations covering the above-described area.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO PAN PETROLEUM COMPANY, INC., A GEOPHYSICAL EXPLORATION PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOPHYSICAL EXPLORATION OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT CONCEPTION, SANTA BARBARA COUNTY, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA, EXCEPT THE FOLLOWING:

1. LANDS INCLUDED IN SECTION 6871.2(b) OF THE PUBLIC RESOURCES CODE;
2. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTH-WESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM SEPTEMBER 1, 1965, THROUGH FEBRUARY 28, 1966.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ALL OF ITS INSPECTION COSTS. THE PERMIT IS TO BE EFFECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN EFFECT FOR THE SAME OPERATING AREA.
