APPLICATION FOR A 49-YEAR EASEMENT TO CONSTRUCT A PUBLIC STREET ON SOVEREIGN LAND IN CORONADO, SAN DIEGO COUNTY; CITY OF CORONADO - W.O. 5657.

An application has been made by HDC Company, a California corporation, on behalf of the City of Coronado, for an easement to construct and maintain a public street on sovereign land located on San Diego Peninsula, City of Coronado, San Diego County (as shown on Exhibit "A").

The sovereign land borders a proposed subdivision owned by HDC Company and is the subject of a dispute between that company and the State with respect to fee ownership.

As a prerequisite for filing of a final subdivision map, the City of Coronado requires an easement for a public street (over the land shown by heavy outline on Exhibit "B"). The sovereign land herein covered is included within that area. The granting of an easement will serve the public interest by providing to the general public access to a beach area fronting the subdivision.
