APPLICATION FOR ISSUATE OF GRAZING LEASE, INYO COUNTY; LAZARO GORRINDO - S.W.O. 8125.

An application has been received from Mr. Lazaro Gorrindo, of Lancaster, California, for a grazing lease for a term of five years, covering Sections 16 and 36, T. 6 S., R. 37 E., M.D.M., containi. a total of 1,280 acres in Inyo County.

An appraisal by the staff on June 3, 1965, indicates the fair grazing rental value to be \$0.01 per acre, or a total of \$12.80 per year; \$64.00 for five years.

THE PROPERTY

Location: 35 miles east of Big Pine.

Access: Section 16 is traversed by A nonmaintained road in fair condition.

Section 36, 1 mile south of Eureka Valley Road, 1s quite mountainous and has no public-road access.

Cover: Desert vegetation displays vigorous growth in Section 16, and sparse and stunted growth in Section 36.

Terrain: The terrain is all mountainous; Section 16 has moderate slopes; Section 36 is precipitous for at least 50% of the acreage.

Elevation: 5,500 feet to 7,000 feet above sea level.

Climate: High Desert
