5. APPLICATION FOR DREDGING PERMIT, SACRAMENTO COUNTY; LEPARTMENT OF WATER RESOURCES - W.O. 5781, P.R.C. 3350.9.

After consideration of Calendar Item 34 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE DEPARTMENT OF WATER RESOURCES A PERMIT FOR THE EXTRACTION OF APPROXIMATELY 34,320 CUBIC YARDS OF MATERIAL FROM THE BED OF THE SACRAMENTO RIVER, WITHOUT THE PAYMENT OF ROYALTY, FOR RECLAMATION AND FLOOD CONTROL IN CONNECTION WITH THE REPAIR OF THE ERODED EAST LEVEE OF THE SACRAMENTO RIVER BETWEEN HOOD AND THE INTERSEC-TICN OF THE PROJECTED LINE OF SUTTERVILLE ROAD AND THE EAST LEVEE, SACRAMENTO COUNTY. THE CONSIDERATION IS THE PUBLIC BENEFIT.

APPLICATION FOR DREDGING PERMIT, SACRAMENTO COUNTY; DEPARTMENT OF WATER RESOURCES - W.O. 5781.

An application has been received from the Department of Water Resources to dredge approximately 34,320 cubic yards of material from the bed of the Sacramento River between Hood and the intersection of the projected line of Sutterville Road and the east levee, Sacramento County, at the following specific locations on the river, and to deposit the dredged material on adjacent eroded levees:

Immediate repairs are necessary on portions of the east levee of the Sacramento River, south of the City of Sacramento, that suffered damage during the recent period of high water. The proposed dredging will be a continuation of levee repair, the first stage of which was completed in June of this year. According to the applicant, it would be desirable to begin this work by Setpember 2, 1965, in order to complete the project before the coming flood season. The Department of Mater Resources will secure project approval from the Corps of Engineers, and will submit a copy of the approval to the State Lands Division. The Department of Fish and Game, and the Department of Parks and Necreation, Division of Beaches and Parks, have been notified, and have approved the proposed dredging. The Reclamation Board is the supervising agency for the project; however, the Department of Water Resources performs the work.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE DEPARTMENT OF WATER RESCURCES A PERMIT FOR THE EXTRACTION OF

APPROXIMATELY 34,320 CUBIC YARDS OF MATERIAL FROM THE BED OF THE SACRAMENTO RIVER, WITHOUT THE PAYMENT OF ROYALTY, FOR RECLAMATION AND F DOD CONTROL IN CONNECTION WITH THE REPAIR OF THE ERODED EAST LEVEE OF THE SACRAMENTO RIVER BETWEEN HOOD AND THE INTERSECTION OF THE PROJECTED LINE OF SUTTERVILLE ROAD AND THE EAST LEVEE, SACRAMENTO COUNTY. THE CONSIDERATION IS THE PUBLIC BENEFIT.
