APPLICATION FOR PERMIT TO INSTALL AND MAINTAIN MARKER BUOYS ON TIDE AND SUBMERGED LANDS OF SUNSET HARBOR IN ORANGE COUNTY; ORANGE COUNTY HARBOR DISTRICT - W.O. 5735.

The Orange County Harbor District has applied for a permit to install and maintain ten marker buoys to delineate navigational waterways in Sunset Harbor, Orange County (as shown on Exhibit "A").

The waterways shown were dredged pursuant to Permit P.R.C. 3121.9, approved by the Commission on May 26, 1964. The project is part of the Aquatic Park development in Sunset Harbor.

The Corps of Engineers has issued a permit for placement of the buoys.

The consideration for the permit will be the public benefit from safety of navigation.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE CRANGE COUNTY HARBOR DISTRICT A TEN-YEAR PERMIT TO INSTALL AND MAINTAIN TEN MARKER PUOYS AS FOLLOWS:
