A STRIP OF SUBMERGED LAND 400 FEET WIDE IN SAN PEDRO BAY, HUNTINGTON BEACH, ORANGE COUNTY, CALIFORNIA; LYING 200 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

COMMENCING AT A BRASS CAP IN CONCRETE ON THE CENTERLINE OF THE HUNTINGTON BEACH PIER, SAID POINT BEING A C.S.L.C. TRIANGULATION STATION DESIGNATED "PIER 2" AND HAVING CALIFORNIA ZONE 6 COORDINATES OF X = 1,466,219.89, Y = 545,733.49; THENCE NORTHEASTERLY ALONG THE CENTERLINE OF SAID PIER 100 FEET TO THE TRUE POINT OF BEGINNING, THENCE SOUTHWESTERLY ALONG THE CENTERLINE OF SAID PIER 800 FEET.

EXCLUDING THEREFROM THE SUBMERGED LAND LYING BELOW THE PIER AND WITHIN 50 FEET OF ITS PERIMETER.

SAID STRIP CONTAINING A NET ACREAGE OF APPROXIMATELY 4.3 ACRES.

APPLICATION FOR PERMIT TO INSTALL AN ARTIFICIAL FISHING REEF IN SUBMERGED LANDS OF SAN PEDRO BAY, HUNTINGTON BEACH, ORANGE COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 5824.

The State Department of Fish and Game has applied for a permit to install an artificial reef on submerged lands of San Pedro Bay at Huntington Beach Pier, Orange County (as shown on Exhibit "A").

The reef, intended to enhance fishing opportunities, will be of stone in units of 250 ton, deposited in single layer, 65 to 85 feet off the pier, 40 feet apart, units to be approximately 100 feet long by 20 feet wide.

The consideration for the permit is to be the public benefit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE DEPARTMENT OF FISH AND GAME, IN CONSIDERATION OF THE PUBLIC BENEFIT, A 49-YEAR PERMIT FOR THE CONSTRUCTION AND MAINTENANCE OF AN ARTIFICIAL FISHING REEF ON THE FCLLOWING-DESCRIBED LANDS:

TRIANGULATION STATION DESIGNATED "PIER 2" AND HAVING CALIFORNIA ZONE 6 COORDINATES OF x=1,466,219.89, y=545,733.49; THENCE NORTHEASTEDLY ALONG THE CENTERLINE OF SAID PIER 100 FEET TO THE TRUE POINT OF BEGINNING, THENCE SOUTHWESTERLY ALONG THE CENTERLINE OF SAID PIER 800 FEET.

EXCLUDING THEREFROM THE SUBMERGED LAND LYING BELOW THE PIER AND WITHIN 50 FEET OF ITS PERIMETER.
