8. APPLICATION FOR IREDGING PERMIT, TIDE AND SUBMERGED LANDS, SAN PABLO BAY, CONTRA COSTA COUNTY; UNION OIL COMPANY OF CALIFORNIA - W.O. 5803, P.R.C. 3387.9.

After consideration of Calendar Item 36 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, SAN PABLO BAY, CONTRA COSTA COUNTY; UNION OIL COMPANY OF CALIFORNIA - W.O. 5803.

An application has been received from Union Oil Company of California for a permit to dredge approximately 37,000 cubic mards of material from a portion of Carquinez Strait, San Pablo Bay, in the vicinity of the Oleum Mefinery, Contra Costa County. Barge and tanken operations are being restricted in the vicinity of the refinery; the perore, permission has been requested to dredge the material from the shipping channels to aid navigation. The aredged material is to be deposited on State land in Carquinez Straits to stream of the Carquinez bridge.

Section 6303 of the Public Resources Code provides that when an applicant has a permit from the Federal Government, the Commission may grant the privilege of depositing material upon or removing or extracting material from, tide or submerged lands owned by the State for the improvement of navigation upon such terms and conditions and for such consideration as will be for the best interests of the State.

The U. S. Corps of Engineers has issued a Department of the Army permit authorizing the conduct of dredging operations at the location described in the application. The Division of Beaches and Parks has reported that issuance of the permit would have no effect upon any of its programs or projects. The Regional Water Pollution Control Board has recommended that as a condition precedent to receiving a permit to perform dredging in the area, the permittee be required "to perform the dredging operations in a manner which will eliminate or minimize silt or turbidity being caused by the operations."

The Department of Fish and Game has recommended that the permit be conditioned upon the recommendation by the Regional Water Pollution Control Board.
