APPLICATION FOR LEASE AND PERMIT ON TIDE AND SUBMERGED LANDS OCEANWARD OF SAN ELIJO STATE BEACH, SAN DIEGO COUNTY; CARDIFF MARINA COMMUNITY SERVICES DISTRICT - W.O. 5742.

The Board of Supervisors of the County of San Diego and the Cardiff Development Company have jointly filed an application on behalf of the Cardiff Marina Community Services District for a lease and permit. The "District" came into legal existence on November 9, 1965.

1. It is proposed to lease tide and submerged lands identified as Parcels SL-1, SL-2, and SL-3, located meavard of the mean high tide line of the San Elijo State Beach, San Diego County (see Exhibit 'A'). The lease of Parcel SL-1 is essential for the creation of a brickwater system to provide ocean access for a proposed residential-marina development within the San Elijo Lagoon area, midway between Cardiffby-the-Sea and Solano Beach, San Mago County. The "system" is to be comprised of a breakwater 1,150 feet long, located approximately 1700 feet from the present shoreline, and of parallel stone jetties, which will provide and protect a 400-foot-wide entra co channel leading to the baring development" project. The north jetty will be about 1080 feet long, and will because to a sater depth of about 18 feet below men lower low water. The south jetty will approximate a length of 1050 feet, and will also terminate in a water dupth of about 18 feet below M.L.L.W. (see Exhibit 'B"). The lease will provide for an casement over, in and upon Parcels SI-2 and SI-3, to be used only for the operation of sand-bypass equipment and for sand-bypass operations but only then necessary as externined by the Division of Beaches and Parks in accordance with the terms and conditions of a permit issued by the State Park Commission to the District; the lease from the State Lands Commission is to be contingent upon the District's receiving such permit or permits as the State Park Commission may deem essential. The Corps of Engineers permit has been received.

Based upon a staff appraisal, the annual rental for a 15-year lease has been established at \$4,667.10, with the first and last years' rental: payable in advance. The lease is to provide for three renewal options of 10 years each upon such reasonable terms and conditions as the State may then impose. A \$200,000 site-clearance bond will also be required.

- 2. In addition, permission has been requested for the Cardiff Marina Community Services District to deposit approximately 500,000 cubic yards of dredge material from the entrance channelway on State-owned tide and submerged lands identified as Parcels SL-4 and SL-5 (see Exhibit "B") subject to the following conditions:
 - a. The permit shall expire five (5) years from the date of issuance.

- b. The permittee shall indemnify the State against any and all losses, damages, claims, demands or action caused by or arising out of the operations of the permittee thereunder.
- c. The permittee shall file with the State and maintain in full force and effect at all times during the term of this permit or any extension thereof a good and sufficient surety bond drawn in favor of the State of California in the penal sum of \$15,000 to guarantee to the State the faithful performance and observance by the permittee of all the covenants and conditions implied or specified in this permit. Further, the permittee shall at all times carry and keep in full force and effect public liability insurance to protect the permittee and the State, as an additional insured, in an amount of at least \$100,000 for each accident and \$50,000 for each person; the permittee shall file the policy for such insurance with the State Lands Commission.

THE PERMITTEE SHALL FILE WITH THE STATE AND MAINTAIN IN FULL FORCE AND EFFECT AT ALL TIMES DURING THE TERM OF THIS PERMIT OR ANY EXTENSION THEREOF A SURETY BOND DRAWN IN FAVOR OF THE STATE OF CALIFORNIA IN THE PENAL SUM OF \$15,000 TO GUARANTEE TO THE STATE THE FAITHFUL PERFORMANCE AND OBSERVANCE BY THE PERMITTEE OF ALL COVENANTS AND CONDITIONS IMPLIED OR SPECIFIED IN THIS PERMIT. FURTHER THE PERMITTEE SHALL AT ALL TIMES CARRY AND KEEP IN FULL FORCE AND EFFECT PUBLIC LIABILITY INSURANCE TO PROTECT THE PERMITTEE AND THE STATE, AS AN ADDITIONAL INSURED, IN AN AMOUNT OF AT LEAST \$100,000 FOR EACH ACCIDENT AND \$50,000 FOR EACH PERSON; THE PERMITTEE SHALL FILE THE POLICY FOR SUCH INSURANCE WITH THE STATE LANDS COMMISSION.

THE CONSIDERATION FOR THE PERMIT IS TO BE THE ENRICHMENT OF THE STATE PUBLIC BEACH AND THE PUBLIC INTEREST.
