APPLICATION FOR PERMIT TO ENTER STATE SCHOOL LAND IN SAN DIEGO COUNTY FOR TEST BORINGS; STATE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. 5939.

The Division of Highways has requested authority to take test borings for material samples, to construct equipment trails and to conduct surveys in Section 36, T. 15 S., R. 3 E., S.B.B.& M., as shown on Exhibit "B".

The project is preliminary to the construction of Interstate Route 8 between San Diego and El Centro. It is anticipated that the borings and survey will continue for a period of six months from January 3, 1966.
