PROPOSED MODIFICATION OF FORM OF OIL AND GAS LEASE, STATE-OWNED UPLAND AREAS INCLUDING SCHOOL LANDS AND LANDS UNDER THE JURISDICTION OF OTHER STATE AGENCIES - W.O. 5434.
