35. PROPOSED ANNEXATION, TIDE AND SUBMERGED LANDS FRONTING CITY OF CARPINTERIA DESIGNATED AS "CARPINTERIA TIDE AND SUBMERGED LANDS ANNEXATION NO. 1-A-1"; SANTA BARRARA COUNTY - W.O. 2400.54, GEO.-SANTA BARBARA CO.

After consideration of Calendar Item 39 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION APPROVES THE PROPOSED OFFSHORE BOUNDARIES OF "CARPINTERIA TIDE AND SUBMERGED LANDS ANNEXATION NO. 1-A-1", DESCRIBED AS FOLLOWS:

THAT PORTION OF THE COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEASTERLY CORNER OF THE CITY OF CARPINTERIA AT THE SOUTHERLY END OF THE 57TH COURSE OF THE CITY LIMITS OF SAID CITY AS SAID CITY LIMITS ARE DESCRIBED IN EXHIBIT "A" IN THE BOARD OF SUPERVISORS RESOLUTION NO. 24988 ON FILE IN THE OFFICE OF THE COUNTY CLERK OF SAID COUNTY; THENCE,

1ST- SOUTH 0° 29' WEST, ALONG THE SOUTHERLY PROLONGATION OF SAID 57TH COURSE HEREINABOVE DESCRIBED TO A POINT THREE GEOGRAPHICAL MILES SEAWARD FROM THE COAST LINE ALONG THE MAINLAND OF THE SANTA BARBARA CHANNEL, AS SAID COAST LINE IS DEFINED IN THE SUPPLEMENTAL DECREE OF THE UNITED STATES SUPREME COURT IN THE UNITED STATES OF AMERICA VERSUS THE STATE OF CALIFORNIA, NO. 5, ORIGINAL, DECIDED JANUARY 31, 1966; THENCE,

2ND- NORTHWESTERLY ALONG A LINE EVERY POINT OF WHICH IS AT A DISTANCE OF THREE GEOGRAPHICAL MILES SEAWARD FROM SAID COAST LINE HEREINABOVE DESCRIBED TO THE INTERSECTION WITH THE SOUTHERLY PROLONGATION OF THE 55TH COURSE OF THE ABOVE DESCRIBED CITY LIMITS OF SAID CITY OF CARPINTERIA; THENCE,

3RD- ALONG SAID SOUTHERLY PROLONGATION OF SAID 55TH COURSE OF SAID CITY LIMITS NORTH 21° 23" EAST, TO THE SOUTHWESTERLY CORNER OF SAID CITY OF CARPINTERIA BEING THE SOUTHERLY END OF THE 55TH COURSE ACCORDING TO THE ABOVE MENTIONED RESOLUTION; THENCE,

4TH- SOUTHEASTERLY ALONG THE 56TH COURSE OF THE ABOVE DESCRIBED CITY LIMITS TO THE POINT OF BEGINNING.

AND INFORMS THE CITY OF CARPINTERIA AND THE EXECUTIVE OFFICER OF THE LOCAL AGENCY FORMATION COMMISSION OF SAID APPROVAL.

PROPOSED ANNEXATION, TIDE AND SUBMERGED LANDS FRONTING CITY OF CARPINTERIA DESIGNATED AS "CARPINTERIA TIDE AND SUBMERGED LANDS ANNEXATION NO. 1-A-1"; SANTA BARBARA COUNTY - W.O. 2400.54.

The State Lands Commission, by letter dated May 9, 1966, was informed by the City of Carpinteria that the City Council has adopted Resolution No. 43, declaring its intention to annex tide and submerged lands fronting the city designated as "Carpinteria Tide and Submerged Lands Annexation No. 1-A-1". The city had previously advised the Commission of its intention to annex certain tide and submerged lands but the descriptions and map required amendment in order to conform with the State boundaries in accordance with the Supplemental Decree entered by the U. S. Supreme Court in U. S. v California, Original No. 5, on January 31, 1966. The offshore boundaries in the pending annexation have been so amended.

Section 35014 of the Government Code provides for approval or disapproval by the State Lands Commission of the offshore boundaries of an annexation proposal where the annexation includes tide or submerged lands in the Pacific Ocean that are owned by the State, and for reporting its determination to the city and to the executive officer of the local agency formation commission. Staff review of the map and the legal description of the proposed annexation has shown compliance with the provisions of said section.

Approval of the map and legal description is made pursuant to Section 35014 of the Government Code and does not constitute approval by the State as owner of the tide and submerged lands to the proposed annexation. This matter will be the subject of separate later consideration by the Commission.

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE PROPOSED OFFSHORE BOUNDARIES OF "CARPINTERIA TIDE AND SUBMERGED LANDS ANNEXATION NO. 1-A-1", DESCRIBED AS FOLLOWS:
