APPLICATION FOR APPROVAL OF THREE LOCATIONS OF SUBMERGED COMMUNICATIONS CABLES ACROSS SACRAMENTO RIVER AND SNODGRASS SLOUGH IN SACRAMENTO COUNTY AND ACROSS STEAMBOAT SLOUGH IN SACRAMENTO AND SOLANO COUNTIES; GENERAL TELEPHONE COMPANY OF CALIFORNIA - W.O. 6193, P.R.C. 3528.9; W.O. 6194, P.R.C. 3529.9; W.O. 6195, P.R.C. 3530.9.

After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE AN AGREEMENT WITH THE GENERAL TELEPHONE COMPANY OF CALIFORNIA, PURSUANT TO THE PROVISIONS OF SECTION 7901 OF THE PUBLIC UTILITIES CODE AND OF ATTORNEY GENERAL'S OPINION NO. 52/56, IN THE FORM PREVIOUSLY ADOPTED BY THE COMMISSION, APPROVING THE LOCATION OF SUBMERGED COMMUNICATIONS CABLES ACROSS UNGRANTED SOVEREIGN LANDS AS FOLLOWS, AND AS SHOWN ON MAPS FILED IN THE OFFICE OF THE STATE LANDS DIVISION:

W.O. 6193 - SACRAMENTO RIVER, APPROXIMATELY 1,335' NORTHEAST OF WALNUT GROVE BRIDGE, WALNUT GROVE, SACRAMENTO COUNTY

W.O. 6194 - SNODGRASS SLOUGH, PARALLEL TO THE NORTH EDGE OF THE TWIN CITIES ROAD BRIDGE, SACRAMENTO COUNTY

W.O. 6195 - STEAMBOAT SLOUGH, BETWEEN GRAND AND RYER ISLANDS IN SACRAMENTO AND SOLANO COUNTIES

APPLICATION FOR APPROVAL OF THREE LOCATIONS OF SUBMERGED COMMUNICATIONS CABLES ACROSS SACRAMENTO RIVER AND SNODGRASS SLOUGH IN SACRAMENTO COUNTY AND ACROSS STEAMBOAT SLOUGH IN SACRAMENTO AND SOLANO COUNTIES; GENERAL TELEPHONE COMPANY OF CALIFORNIA - W.O.s 6193, 6194, AND 6195.

The General Telephone Company of California has applied for approval of the locations of three separate submerged communications cables crossing ungranted sovereign lands of Sacramento River at Walnut Grove (Exhibit "A"), of Snodgrass Slough near Twin Cities Road Bridge in Sacramento County (Exhibit "B"), and of Steamboat Slough between Grand and Ryer Islands in Sacramento and Solano Counties (Exhibit "C").

The Commission previously adopted an "Approval-of-Location Agreement Form" to be used for telephone and telegraph facilities crossing State lands, in accordance with Section 7901 of the Public Utilities Code and with Attorney General's Opinion No. 52/56.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICERS BE AUTHORIZED TO EXECUTE AN AGREEMENT WITH THE GENERAL TELEPHONE COMPANY OF CALIFORNIA, PURSUANT TO THE PROVISIONS OF SECTION 7901 OF THE PUBLIC UTILITIES CODE AND OF ATTORNEY GENERAL'S OPINION NO. 52/56, IN THE FORM PREVIOUSLY ADOPTED BY THE COMMISSION, APPROVING THE LOCATION OF SUBMERGED COMMUNICATIONS CABLES ACROSS UNGRANTED SOVEREIGN LANDS AS FOLLOWS, AND AS SHOWN ON MAPS FILED IN THE OFFICE OF THE STATE LANDS DIVISION:

- W.O. 6193 - SACRAMENTO RIVER, APPROXIMATELY 1,335' NORTHEAST OF WALNUT GROVE BRIDGE, WALNUT GROVE, SACRAMENTO COUNTY
- W.O. 6194 - SNODGRASS SLOUGH, PARALLEL TO THE NORTH EDGE OF THE TWIN CITIES ROAD BRIDGE, SACRAMENTO COUNTY
- W.O. 6195 - STEAMBOAT SLOUGH, BETWEEN GRAND AND RYER ISLANDS IN SACRAMENTO AND SOLANO COUNTIES
