

4. APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR POWER LINE OVER THE OLD BED OF THE AMERICAN RIVER, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. 6245, P.R.C. 3626.9.

After consideration of Calendar Item 33 attached, and upon motion duly made and carried, the following resolution was adopted:

PURSUANT TO THE PROVISIONS OF PUBLIC UTILITIES CODE SECTION 12808, THE COMMISSION AUTHORIZES THE EXECUTIVE OFFICER TO ISSUE A 49-YEAR LIFE OF STRUCTURE PERMIT TO THE SACRAMENTO MUNICIPAL UTILITY DISTRICT FOR THE CONSTRUCTION AND MAINTENANCE OF A 12 KV POWER LINE OVER THE FOLLOWING-DESCRIBED LANES:

A STRIP OF LAND 10 FEET WIDE IN THE BED OF THE AMERICAN RIVER, SACRAMENTO COUNTY, APPROXIMATELY 7 MILES EASTERLY OF THE CITY OF SACRAMENTO; LYING 5 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

COMMENCING AT THE MOST SOUTHERLY POINT OF LOT 25 PER OFFICIAL MAP OF "HOGGIN BOTTOM SUBDIVISION NO. 1" FILED IN BOOK 20 OF MAPS, MAP NO. 2 IN THE OFFICE OF THE SACRAMENTO COUNTY RECORDER; THENCE S. 11° 34' W. 454 FEET, S. 55° 26' E. 617.97 FEET AND S. 4° 09' 40" E. APPROXIMATELY 370 FEET TO A POINT ON THE LAST NATURAL LOW WATER MARK OF THE RIGHT BANK OF THE AMERICAN RIVER, SAID POINT BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE S. 4° 09' 40" E. 160 FEET; CONTAINING 0.027 ACRE MORE OR LESS.

APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR POWER LINE OVER THE OLD BED OF THE AMERICAN RIVER, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. 6245.

The Sacramento Municipal Utility District has applied for a right-of-way easement to construct a 12 kv power line across a portion of the old bed of the American River to service the Arcade Water District, at a site about  $2\frac{1}{2}$  miles east of the Watt Avenue Bridge near Sacramento (see Exhibit "A").

The applicant advises that it is not feasible to underground the line in the area due to the prevalence of washouts in periods of heavy weather.

Public Utilities Code Section 12808 provides as follows:

"A district may construct works across or along any street or public highway, or over any of the lands which are the property of the State, and it shall have the same rights and privileges appertaining thereto as are granted to municipalities within the State. The district shall restore any such street or highway to its former state as near as may be, and in compliance with local ordinances, and shall not use it in a manner to unnecessarily impair its usefulness. A district may also construct its works across any stream or watercourse."

IT IS RECOMMENDED THAT, PURSUANT TO THE PROVISIONS OF PUBLIC UTILITIES CODE SECTION 12808, THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A 49-YEAR LIFE OF STRUCTURE PERMIT TO THE SACRAMENTO MUNICIPAL UTILITY DISTRICT FOR THE CONSTRUCTION AND MAINTENANCE OF A 12 kv POWER LINE OVER THE FOLLOWING-DESCRIBED LANDS:

A STRIP OF LAND 10 FEET WIDE IN THE BED OF THE AMERICAN RIVER, SACRAMENTO COUNTY, APPROXIMATELY 7 MILES EASTERLY OF THE CITY OF SACRAMENTO; LYING 5 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

COMMENCING AT THE MOST SOUTHERLY POINT OF LOT 25 PER OFFICIAL MAP OF "HOGGIN BOTTOM SUBDIVISION NO. 1" FILED IN BOOK 20 OF MAPS, MAP NO. 2 IN THE OFFICE OF THE SACRAMENTO COUNTY RECORDER; THENCE S.  $11^{\circ} 34'$  W. 454 FEET, S.  $55^{\circ} 26'$  E. 617.97 FEET AND S.  $4^{\circ} 09' 40''$  E. APPROXIMATELY 370 FEET TO A POINT ON THE LAST NATURAL LOW WATER MARK OF THE RIGHT BANK OF THE AMERICAN RIVER, SAID POINT BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE S.  $4^{\circ} 09' 40''$  E. 160 FEET; CONTAINING 0.027 ACRE MORE OR LESS.
