APPROVAL OF NINTH MODIFICATION, 1966 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY - W.O. 5200.301 AND W.O. 5200.317.

The City of Long Beach and the State, pursuant to the provisions of Chapter 138, Section 5(g), Statutes of 1964, 1st E.S., have mutually agreed to the Ninth Modification of the 1966 Flan of Development and Operations and Budget, Long Beach Unit, as set forth in THUMS Approval Request 37-66.

The Ninth Modification of the 1966 Plan and Budget covers the five items listed below that are considered essential for the continued orderly development of the Long Beach Unit:

- 1. Permit the change of the final surface location of any well previously or hereafter authorized to be drilled on Pier J or Island "A", pursuant to the 1966 Plan, with the written approval of the Director or Assistant Director, Department of Oil Properties, City of Long Beach, and the Manager or Assistant Manager of Long Beach Operations, State Lands Division, subject to the provisions set forth in THIMS Approval Request 37-66.
- 2. Provide for a contingent liability in the 1966 Plan and Budget of such amounts as may hereafter prove necessary to defend any legal proceeding which may be commenced by the owner of an uncommitted town lot parcel included in the Long Beach Unit, pursuant to the provisions of Section 3608 of the Public Resources Code, and to pay or satisfy any adverse judgment resulting from such legal proceeding.
- 3. Effect an accounting exchange in the Marine Transportation Expense budget categories to provide that marine transportation charges will be allocated only to those projects thick are veryed by the marine fleet. This accounting change will lok affect the budged total since it is merely a change in allocation.
- 4. Establish a contingent liability fund of approximately \$440,455 to provide for the potential purchase of the rented drilling substructures on Island "A". The Unit will have the option to buy the substructures at any time, and will become the owner without additional payment at the point that rentals paid equal the selling price. This liability will decrease approximately \$11,000 each month until July 31, 1969, and approximately \$9,400 each month thereafter.
- 5. Provide funds necessary to commence several projects not previously anticipated and to complete certain projects where the cost was originally underestimated, as detailed in THUMS Approval Request 37-66.
