13. APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT, SUBMERGED LAND IN LAKE TAHOE, PLACER COUNTY; FIRMIN A. GRYP, ET AL. - W.O. 6385, P.R.C. 3704.1.

After consideration of Calendar Item 3 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO FIRMIN A GRYP, ET AL., FOR A FEE OF \$25, A FIVE-YEAR RECREATIONAL MINOR-STRUCTURE PERMIT FROM SEPTEMBER 26, 1966, FOR THE MAINTENANCE OF AN EXISTING PIER ON THE FOLLOWING-DESCRIBED LAND:

A PARCEL OF SUBMERGED LAND IN THE BED OF LAKE TAHOE LYING ADJA-CENT TO ASSESSORS MAP PARCEL NO. 84-172-01 NEAR SUNNYSIDE, PLACER COUNTY, CALIFORNIA; BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT A  $1\frac{1}{2}$ " IRON PIPE LOCATED ON THE EASTERLY RIGHT-OF-WAY LINE OF STATE HIGHWAY 89, SAID IRON PIPE IS SHOWN AS "C" ON SHEET 8 OF 22 OF A SERIES OF MAPS OF A "SURVEY OF THE LOW WATER MARK ON THE SHORE OF LAKE TAHOE," DATED SEPTEMBER 1950 AND FILED MAY 3, 1965 IN BOOK 2 OF SURVEYS AT PAGE 71 RECORDS OF PLACER COUNTY; SAID IRON PIPE HAS APPROXIMATE CALIFORNIA ZONE 2 COORDI-NATE VALUES OF X = 2,523,274, Y = 539,775; THENCE S. 89° 40' 42" E. 476.68 FEET, N. 18° 03' 48" E. 42.00 FEET, S. 89° 07' 12" E. 61.71 FEET, AND S. 80° 25' 57" E. 695.90 FEET MORE OR LESS TO A POINT ON THE LOW WATER MARK OF LAKE TAHOE, SAID P^INT BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE S. 83° 02' 49" E. 80.00 FEET, S. 6° 57' 11" W. 30.00 FEET, N. 83° 02' 49" W. 80.00 FEET, AND N. 6° 57' 11" E. 30.00 FEET TO THE TRUE POINT OF BEGINNING; CONTAINING 0,055 ACRE MORE OR LESS.

APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT, SUBMERGED LAND IN LAKE TAHOE, PLACER COUNTY; FIRMIN A. GRYP, ET AL. - W.O. 6385.

An application has been received from Firmin A. and Janice L. Gryp, Archie E. and Barbara L. Peterson, and Myron E. and Patricia T. Etienne, owners of the adjacent upland, improved with three residential structures, for a permit to maintain an existing pier on State-owned submerged land near Sunnyside, Lake Tahoe, Placer County (as shown on Exhibit "A").

The pier, which has existed for many years, was covered by a 10-year rentfree permit that expired on September 25, 1966. Inasmuch as the present land use does not qualify for a rent-free permit under current law, a 5year recreational minor-structure permit for a total fee of \$25 is indicated according to Commission policy now in effect.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO FIRMIN A. GRYP, ET AL., FOR A FEE OF \$25, A FIVE-YEAR RECRE-ATIONAL MINOR-STRUCTURE PERMIT FROM SEPTEMBER 26, 1966, FOR THE MAINTE-NANCE OF AN EXISTING PIER ON THE FOLLOWING-DESCRIBED LAND:
