After consideration of Calendar Item 15 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO OFFER A PARCEL OF TIDE AND SUBMERGED LAND IN CONTRA COSTA AND SOLANO COUNTIES FOR OIL AND GAS LEASE PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE.

THE LEASE AWARD IS TO BE MADE TO THE QUALIFIED BIDDER OFFERING THE HIGHEST CASH-BONUS PAYMENT IN CONSIDERATION OF THE ISSUANCE OF THE OIL AND GAS LEASE. THE BID-LEASE FORM TO BE USED FOR THE PARCEL SHALL BE THE FORM APPROVED AND ADOPTED BY THE COMMISSION ON NOVEMBER 15, 1960, AMENDED NOVEMBER 6, 1963, AND AMENDED TO CONFORM TO THE 1966 STATUTORY AMENDMENTS RELATING ONLY TO THE DEFINITION OF MULTIPLE COMPLETION OF OIL WELLS.

THE LEASE RENTAL IS TO BE \$1.00 PER ACRE PER YEAR.

PROPOSED OIL AND GAS LEASE, TIDE AND SUBMERGED LAND; CONTRA COSTA AND SOLANO COUNTIES - W.O. 6220 (FARCEL 47).

On September 26, 1966, the Commission authorized the Executive Officer to proceed, as required by Section 68',3.2 of the Public Resources Code, with the publication of a notice that the Commission intends to consider offering a lease for the extraction of oil and gas from an area of tide and submerged lands in Suisun Bay, in the counties of Solano and Contra Costa. The Public Resources Code provides that any affected city or county may, within 30 days after the publication of such notice, request in writing to the Commission that a hearing be held with respect thereto. The notice was published October 6 and 13, 1966, the 30-day period has elapsed, and no request that a hearing be held has been received.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO OFFER A PARCEL OF TIDE AND SUBMERGED LAND IN CONTRA COSTA AND SOLANO COUNTIES FOR OIL AND GAS LEASE PURSUANT TO DIVISION 6 OF THE FUBLIC RESOURCES CODE.
