APPLICATION FOR PERMITS TO PIACE WATER-QUALITY MONITORING STATIONS ON STATE LAND IN SACRAMENTO, MOKELUMNE, AND OLD RIVERS; SACRAMENTO, SAN JOAQUIN, AND CONTRA COSTA COUNTIES; U. S. DEPARTMENT OF THE INTERIOR, BUREAU OF RECLAMATION - W.O.s 6104, 6105, 6153 AND 6222.

The U.S. Department of the Interior, Bureau of Reclamation, requests 49-year permits to place water-quality monitoring recorder stations on State sovereign land located as follows:

- 1. W.O. 6104 Left bank of the Sacramento River just upstream from Three Mile Slough, Sacramento County (see Exhibit "A").
- 2. W.O. 6105 Left bank of Sacramento River Northwest of Emmaton, Sacramento County (see Exhibit "B").
- 3. W.O. 6153 Right bank of the South Fork of the Mokelumne River at the south tip of Staten Island just north of Terminous, San Joaquin County (see Exhibit "C").
- 4. W.O. 6222 Left bank of Old River at the tide recorder station on Clifton Court Tract, Contra Costa County (see Exhibit "D").

The proposed station, are to be part of the program for water-salinity control of the Delta Area. The purpose is to insure suitable quality of irrigation water for farming, and the operation will be conducted in cooperation with the State Department of Water Resources. A typical installation involves a 5-foot-wide timber structure with a 6' x 6' meter house at the waterward end.

Navigational permits have been issued by the U.S. Army Corps of Engineers, and the projects have been processed affirmatively through interested State agencies. The applicant has appropriate property rights in the riparian land at each site.

The consideration for issuance of the remits will be the public benefit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE U. S. DEPARTMENT OF THE INTERIOR, BUREAU OF RECLAMATION, IN CONSIDERATION OF THE PUBLIC BENEFIT, A 49-YEAR PERMIT FOR THE INSTALLATION, OPERATION, AND PROPER MAINTENANCE OF A WATER-QUALITY MONITORING RECORDER STATION ON EACH OF THE FOUR PARCELS OF LAND DESCRIBED ON EXHIBIT "E" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
