6. APPLICATION FOR RECREATIONAL MINOR-STRUCTURE PERMIT TO MAINTAIN A PIER AND FLOAT ON STATE LAND IN COLORADO RIVER, SAN BERNARDINO COUNTY; GLEN D. PENROD - W.O. 5869, P.R.C. 3722.1.

After consideration of Calendar Item 22 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO GLEN D. PERROD, FOR A FEE OF \$25, A FIVE-YEAR RECREATIONAL MINOR-STRUCTURE PERMIT FOR THE MAINTENANCE OF AN EXISTING PIER AND FLOAT ON THE FOLLOWING-DESCRIBED LAND:

A STRIP OF LAND 50 FEET WIDE IN THE BED OF THE COLORADO RIVER ADJACENT TO LOT C-36b ON THE RIGHT BANK OF SAID RIVER, SAN BERNARDINO COUNTY, CALIFORNIA, LYING PARALLEL TO THE LAST NATURAL LOW WATER MARK AND BEING ADJACENT TO AND EXTENDING 100 FEET SOUTHWESTERLY FROM A LINE IDENTIFIED AS EXTENDING SOUTHEASTERLY AT RIGHT ANGLES FROM THE CENTERLINE OF PARKER DAM COUNTY ROAD AND BEING 153' SOUTHWESTERLY ALONG SAID ROAD CENTERLINE FROM AN IRON HUB LOCATED AT THE INTERSECTION OF THE CENTERLINE OF THE AFOREMENTIONED ROAD AND THE NORTH BOUNDARY OF SECTION 30, T. 2 N., R. 27 E., S.B.B.& M.; SAID IRON HUB IS DISTANT EASTERLY 3,024.8 FEET FROM THE NORTHWEST CORNER OF SAID SECTION 30; CONTAINING 0.115 ACRE MORE OR LESS.
