2. LANDS LYING ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTH-EASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.

APPLICATION FOR EXTENSION OF TERM OF GEOPHYSICAL EXPLORATION PERMIT P.R.C. 3327.1; SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE AND SAN DIEGO COUNTIES; PAN PETROLEUM COMPANY, INC.

An application has been received from Pan Petroleum Company, Inc., for an extension of the term of Geophysical Exploration Permit P.R.C. 3327.1 from March 1, 1967, through August 31, 1967, in order to continue geophysical exploration operations. The present permit will expire on February 28, 1967.
