2. LANDS ADJACENT TO THE MAINLAND BETWEEN A LINE FORMING THE NORTH-WESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY, AND THE SEAWARD EXTENSION THEREOF, AND A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF.

ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
