APPLICATION FOR COMMERCIAL MINOR-STRUCTURE PERMIT TO MAINTAIN EXISTING MOORING BUOYS ON SURMERGED LAND ADJACENT TO SANTA CATALINA ISLAND, LOS ANGELES COUNTY; AMERICAN CEMENT CORPORATION, CATALINA ROCK DIVISION - W.O. 5885.

The Catalina Rock Division, American Cement Corporation, a Delaware corporation, with California headquarters in Los Angeles, has requested a five-year permit to maintain nine existing mooring buoys on submerged land off Blue Cavern Point, Santa Catalina Island, Los Angeles County (as shown on Exhibit "A").

Six of the buoy sites were formerly under lease to Graham Brothers, Inc., the former owner of a quarry at the cited location. The buoys are used by vessels and barges servicing the quarry. The U.S. Army Corps of Engineers has issued a navigational permit covering the nine sites.

A fee of \$100 will be charged for each site, totaling \$900.
