San Clemente Sportfishing, Inc., has applied for a commercial minor-structure permit to maintain up to nine mooring buoys on State land off San Clemente Pier in Orange County (as shown on Exhibit "A").

The buoys, which have been under navigational and land use permits for several years, are in seasonal use by the applicant's fleet of sport-fishing and charter boats.

The fee for each buoy during a 5-year term will be \$100, or a total of \$900, pursuant to Commission policy now in effect.
