APPLICANT: Konocti County Water District

LOCATION: Sovereign land in the bed of Clear Lake, Lake County

PROPOSED USE: The installation of a water-intake pipeline

TERMS: Initial period: 49 years

CONSIDERATION: No charge

BASIS FOR CONSIDERATION:

Monetary consideration is prohibited by Sec. 12803 of the Public Utilities Code.

EXHIBIT "A"

A strip of submerged land 20 feet wide, in the bed of Clear Lake, Lake County, California, situate in Section 23, T. 13 N., R. 7 W., M.D.B. & M., lying 10 feet on each side of the following-described centerline:

Beginning at a point on the Low Water Mark of Clear Lake which bears S. 24° 06' 09" W. (California Zone 2 grid bearing) 483.90 feet, more or less from a iron bar tagged L. S. 2581 and located at the southwest corner of Lot 6 of "Club House Addition to Clear Lake Highlands, Third Portion of Tracts A and B," as said tract is shown on a map recorded October 15, 1924 in Book 4 of Town Maps at page 4 said southwest corner has California Zone 2 coordinate values of X = 1,819,159.77, Y = 467,871.39; thence from the point of beginning S. 82° 09' W. 700 feet; containing 0.321 acre more or less.
