33. EXTENSION OF TERM, GEOLOGICAL SURVEY PERMIT P.R.C. 2827.1; SANTA BARBARA SOUTH THROUGH SAN DIEGO COUNTY; SHELL OIL COMPANY.

After consideration of Calendar Item 13 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO SHELL OIL COMPANY AN EXTENSION OF THE TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2827.1, FOR THE PERIOD JULY 16, 1967, THROUGH JANUARY 15, 1968, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT CONCEPTION, SANTA BARBARA COUNTY, AND THE SCUTHERN BOUNDARY OF THE STATE OF CALIFORNIA. APPLICATION FOR EXTENSION OF TERM OF GEOLOGICAL SURVEY PERMIT P.R.C. 2827.1; SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; SHELL OIL COMPANY.

An application has been received from Shell Oil Company for an extension of the term of Geological Survey Permit P.R.C. 2827.1 from July 16, 1967, through January 15, 1968, in order to continue core-drilling operations. The present permit will expire on July 15, 1967.
