APPROVAL OF THE FOURTH MODIFICATION OF THE 1967 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY - W.O.'s 5200.301 AND 5200.317.

The City of Long Beach and the State, pursuant to the provisions of Section 5(g), Ch. 138/64, 1st E.S., have mutually agreed to the Fourth Modification of the 1967 Plan of Development and Operations and Budget, increasing the total budgeted amount by \$36,000 to provide handrails around all cellars and concrete pipe trenches on Pier J.

This work, not anticipated when the 1967 Plan and Budget was prepared, is now required in order to meet State safety standards and to comply with a report by the Division of Industrial Safety, State of California.

The Executive Officer, by letter dated April 28, 1967, consented to the request for approval of the Fourth Modification of the 1967 Plan of Development and Operations and Budget, Long Beach Unit.
