# LIFE-OF-STRUCTURE PERMIT (49 YEARS)

APPLICANT: State of California, Department of General Services.

LOCATION: Sovereign land of the American River, City of Sacramento, Sacramento County.

PROFOSED USE: To complement development of the new California State Exposition and Fair site by construction of river bank protection; to be used for bridle paths and hiking trails.

TERMS: Initial period: 49 years.

CONSIDERATION: The public use and benefit.

PREREQUISITE ITEMS:

U.S.A. Corps of Engineers navigational permit issued. Applicant is owner of upland. Bridle paths and hiking trails to be constructed under a license with the County of Sacramento, Department of Recreation, as part of the American River Parkway System.
